ADOPT-A-ROAD PROGRAM MEMBERSHIP TERMS

Our organization, _____, agrees to participate in cleanups and report cleanup results on our adopted mile(s) as often as necessary, but not less than once every thirty (30) days. We understand that failure to participate in cleanups and/or report results will result in this contract being null and void and our roadway signs being removed (where applicable). We understand that it is our responsibility to update contact and activity information with the Clean It Up, Green It Up Activity's Adopt-A-Road Program and lack of such information can warrant termination procedures.

SAFETY TIPS

Remember to protect yourselves and others when working in a dangerous environment.

Agree to: (1) Park all vehicles clear of the roadway; (2) Stop work in foul weather; (3) Wear light colored clothing and safety vests; (4) Wear gloves; (5) Wear leather shoes or boots; (6) Wear a hat and long sleeves; (7) Avoid over exertion; (8) Provide adequate supply of drinking water; (9) Do not remove hazardous substances; (10) Be alert for snakes; (11) Avoid contact with noxious weeds and areas where herbicides were applied; (12) Do not pick up items on bridges, in tunnels or on an overpass; (13) Stay clear of any construction; (14) Do not enter the roadway or shoulder. In case of emergency, every crew should have a first aid kit and transportation available.

In consideration for the mutual covenants contained herein, the Private Concern covenants and agrees that it will indemnify and hold harmless the City of Jacksonville, Keep Jacksonville Beautiful and all of the City of Jacksonville's officers, agents and employees from any claim, loss, damage, cost, charge or expense arising out of any act, action, neglect or omission by the Private Concern during the performance of the contract, whether direct or indirect and whether to any person or property to which city of said parties may be subject, except that neither the Private Concern nor any of its sub-subcontractors will be liable under the section for damages arising out of injury or damage to property directly caused or resulting from the sole negligence of the City of Jacksonville, or any of their officers, agents or employees.

The Private Concern hereby acknowledges receiving a copy of the City's Adopt-A-Road Safety Tip Guidelines for Right-Of-Way Occupation and agrees to provide a copy of same to all those who will be on the right-of-way of the city pursuant to the Adopt-A-Road Program.
