## **Chair Report**

Chair Donna Kuldau reported the Commission 2019-2020 program selection is finalized. Annual retreat was in May and during the meeting Commissioners voted on Mental Wellness Relevant to Women as the New Year focus. The focus for the past two years had been Women's Equal Pay. The Commission created Committees and they will report progress on a monthly basis. Vice Chair Pemberton will chair July's meeting and in August there will be Commission elections with the new slate of officers beginning September.

## **Committee Reports**

Governance – Chair Kuldau reported the Committee will meet in July and discuss nominations.

- <u>Advocacy and Education</u> Vice Chair Pemberton reported the Committee has not met. They will work on getting speakers for the meeting and will tap into Commissioner Grant's hospital contacts.
- <u>Communication</u> Commissioner Grant reported they plan on creating a Women's Organizations database and have FSCJ students assist in its managing. They will solicit volunteers from several of the High School programs. The Committee would like to upload contacts on the MCSW website with 1-800 numbers and resources and have members promote the website. Initiate a red table style roundtable discussion with mental health professionals and have pictures and videos of the events. Create a hashtag for social media and a posting calendar for MCSW approval. Promote the Women Up event and have pre-selected professionals for the workshops. Create tracks for professionals and for the public with the possibility of professionals being able to receive CEU credits.
- <u>Events</u> Commissioner Taylor reported they outlined how the Committee will do everything from sign in sheets to clean up.

Chair Kuldau reminded the Commission their goal is to raise awareness of the issue, highlight the services and the avenues for help available and advise the Mayor of what is going affecting the Women in Jacksonville. Speakers are to be geared toward the topic Women's Mental Wellness and the group focus needs to be narrowed down by August.

Vice Chair Pemberton stated Committees need to keep in mind what they will be reporting back to the Mayor, the goal and how they are measuring it. Communications will need to develop a draft schedule of a plan with milestones and goals.

Commissioner DeWitt indicated she would like to learn more of the topic before making a focused decision. Commissioner Jackson will email Liaison Florio information regarding Mental Wellness topics.

Liaison Florio indicated Mental Wellness may be tied to the past topic and the board may utilize advisory groups to contribute to some of the committees.

## **New Business**

Liaison Florio reported the Governance Committee met and revised the By-Laws. Commissioners should review the by-laws and if they have any edits or issues they need to get them to the Liaison. Edits and changes will be considered by the Governance Committee and the final bylaws will be sent out with the July meeting board packet. The revised by-laws have been brought into alignment with the Executive Order. In the July meeting the Commission will take action on the by-laws.
