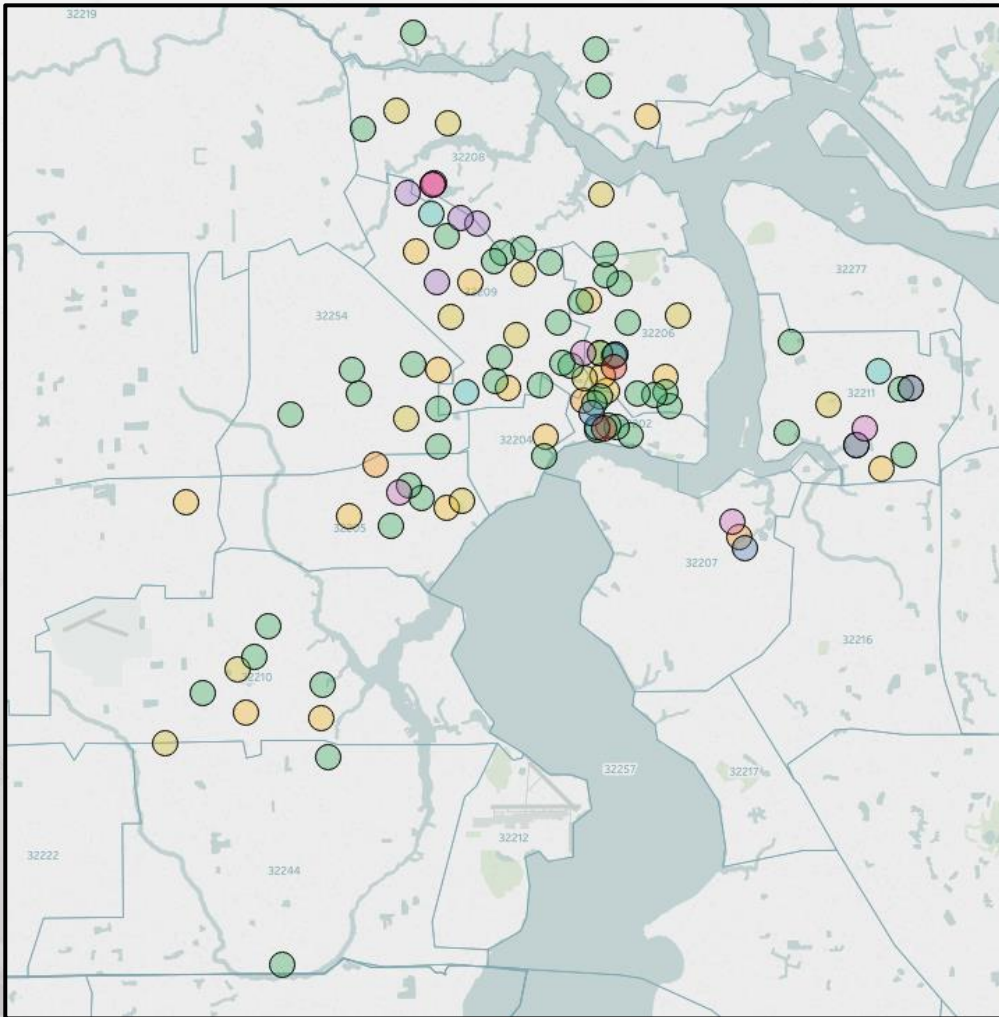

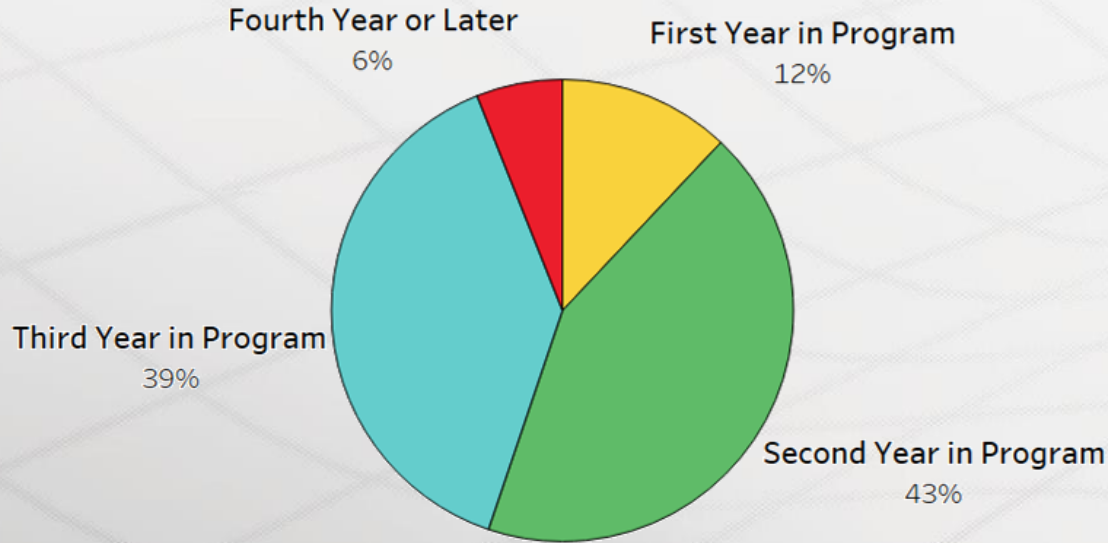

Data Received from Family Foundations



Family Foundations submitted data for 241 clients from 2012 to present. Of these clients:

- 37 participants have successfully closed their case
- 3 have been in the program for at least 1000 days
 - One of which has completed the transition from poverty.

Recommendations

- Ensure proper data collection in the future
 - NLP Logix will store data for future evaluation
 - This will allow visit by visit tracking of current participants
- Transition to performance based evaluation
- Work with Family Foundations to better understand the 9 pivotal assets
 - Why are families starting with 5-6 assets?
 - Should Parent University be included in these metrics?

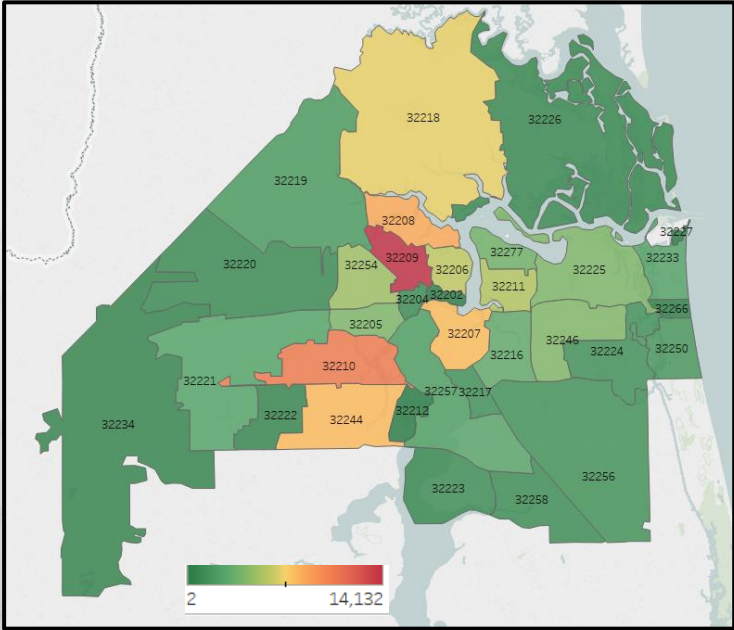

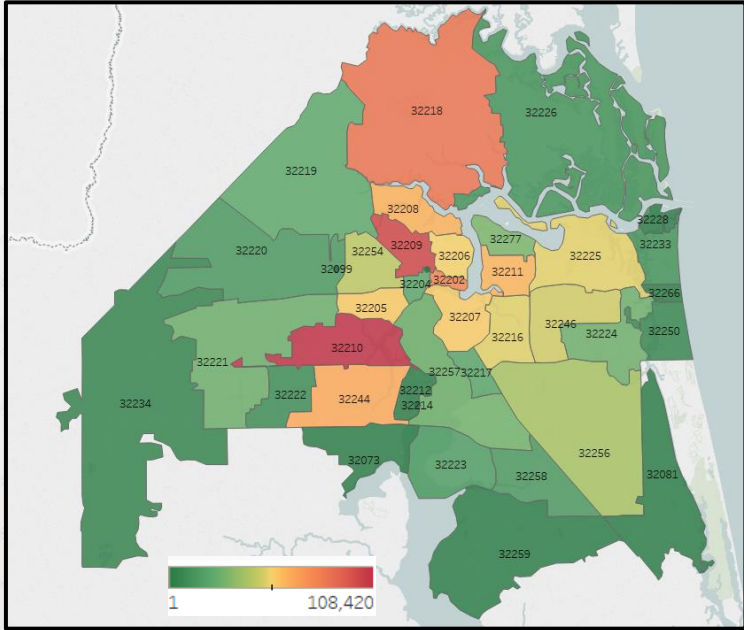
Comparing Crime by ZIP Code

DJJ



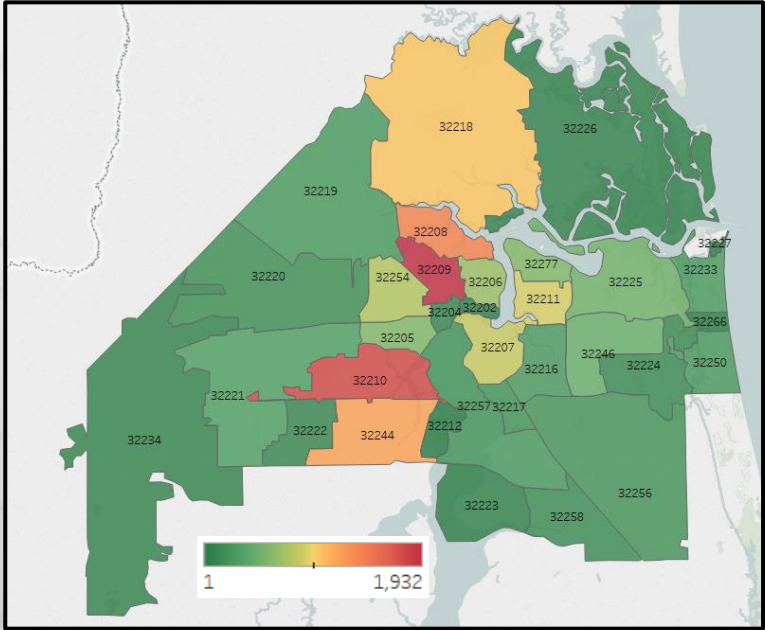

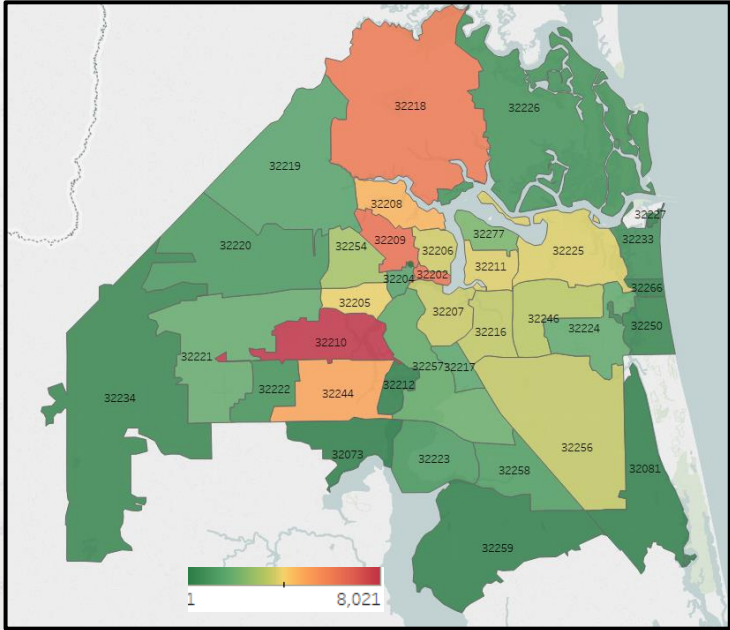
Comparing Crime by ZIP Code

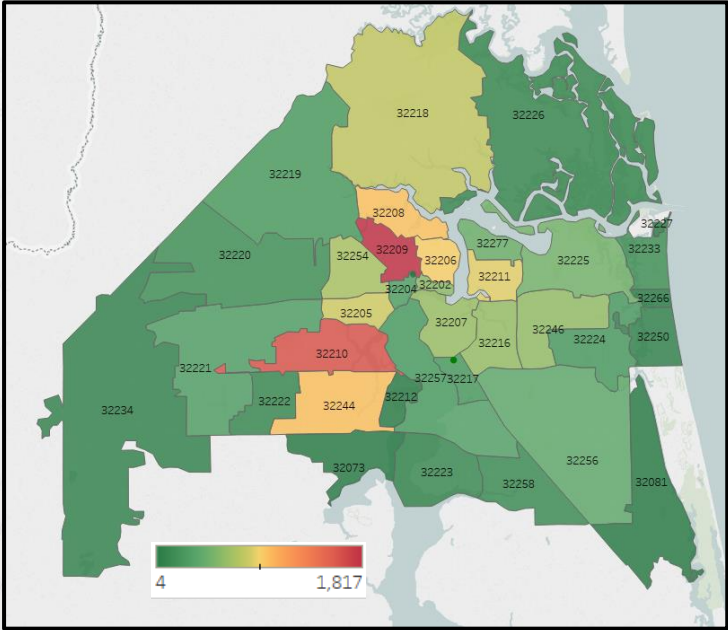
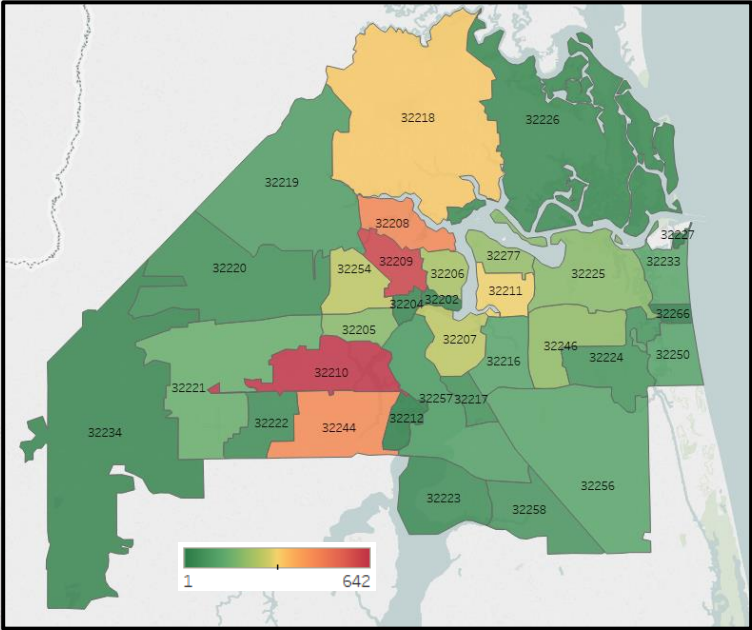


Comparing Crime by ZIP Code

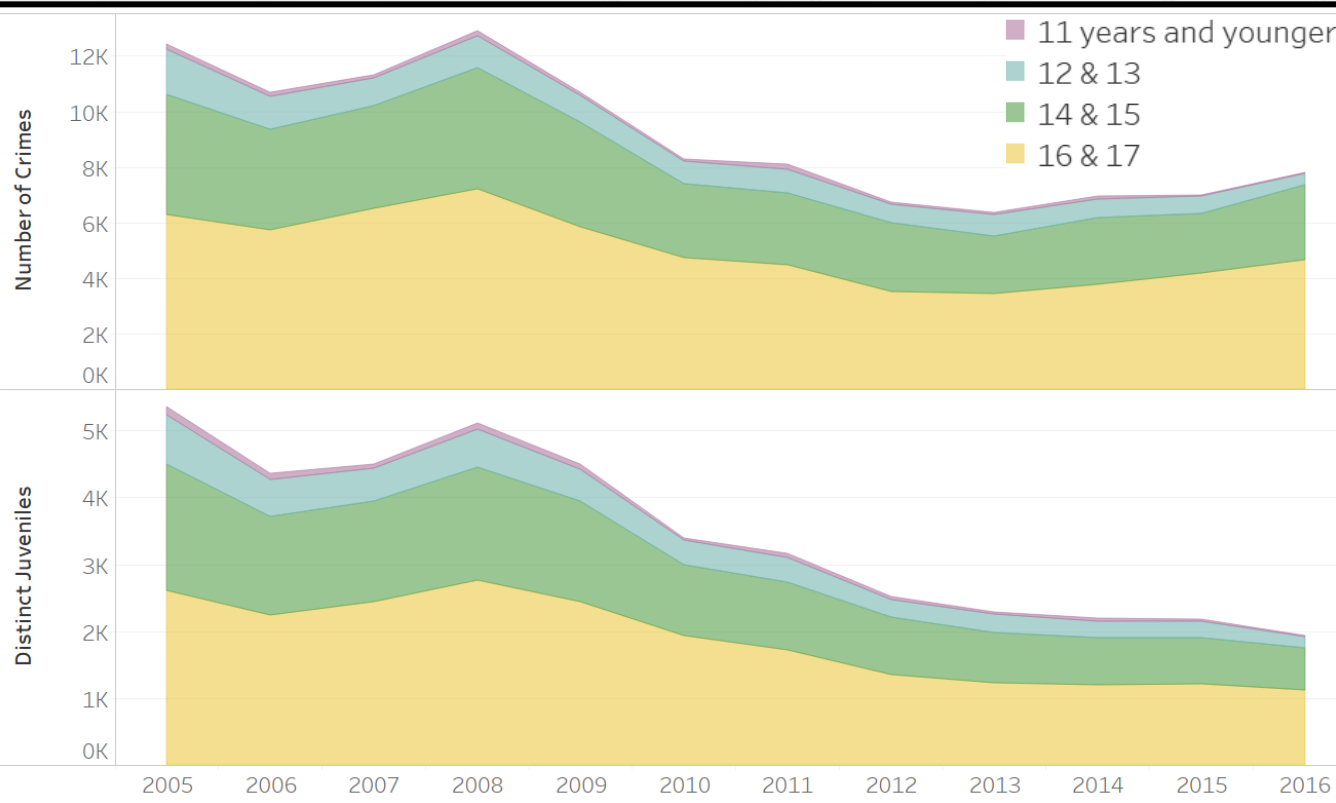
Violent Crime – 2015 & 2016

Timeline of Juvenile Crime

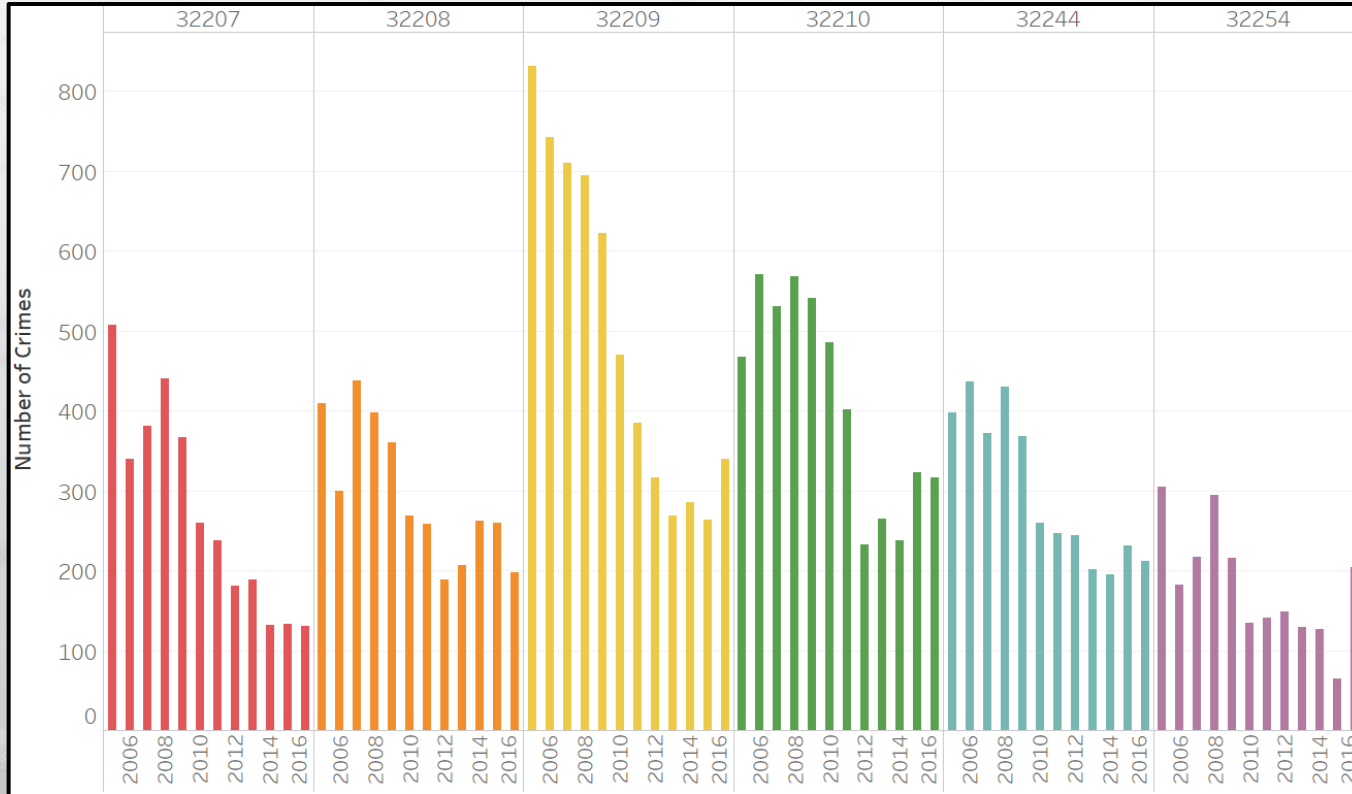


Overall, Juvenile Crime has been decreasing from 2008 to present.

The number of crimes is stable/showing slight increases in the last year, while the number of juveniles involved has continued to decrease.

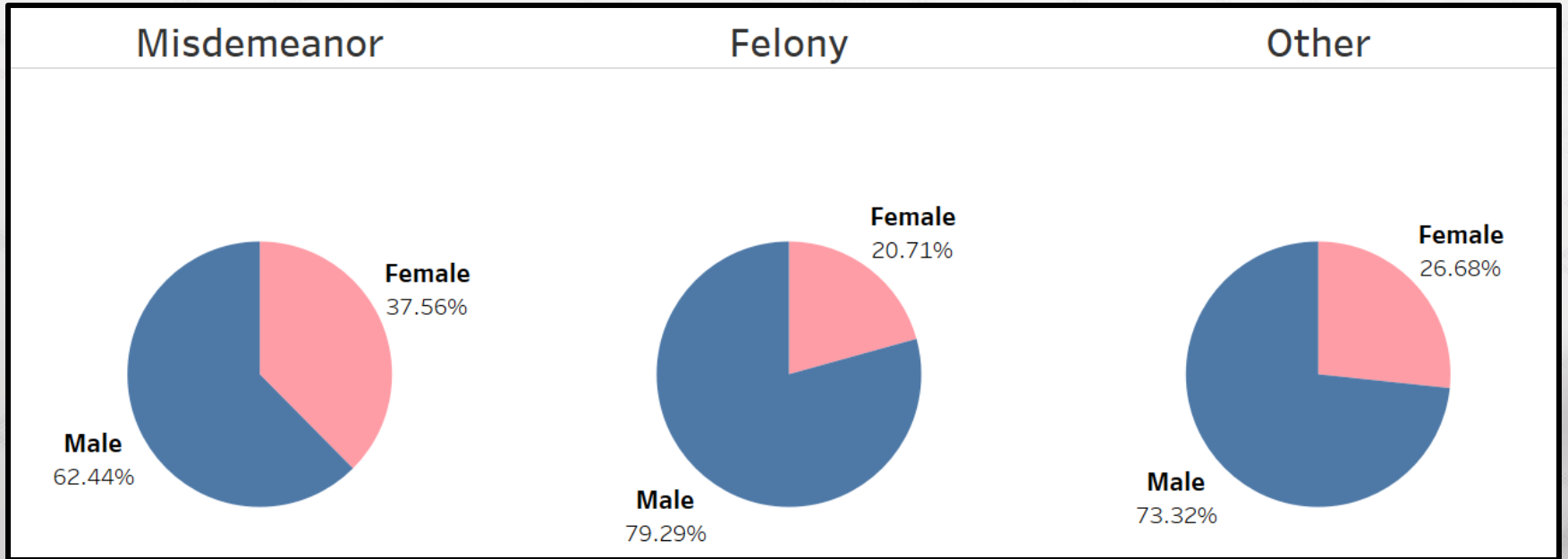
We see similar trends for violent crimes and within the Journey ZIP Codes as a whole.

Timeline of Select ZIP Codes

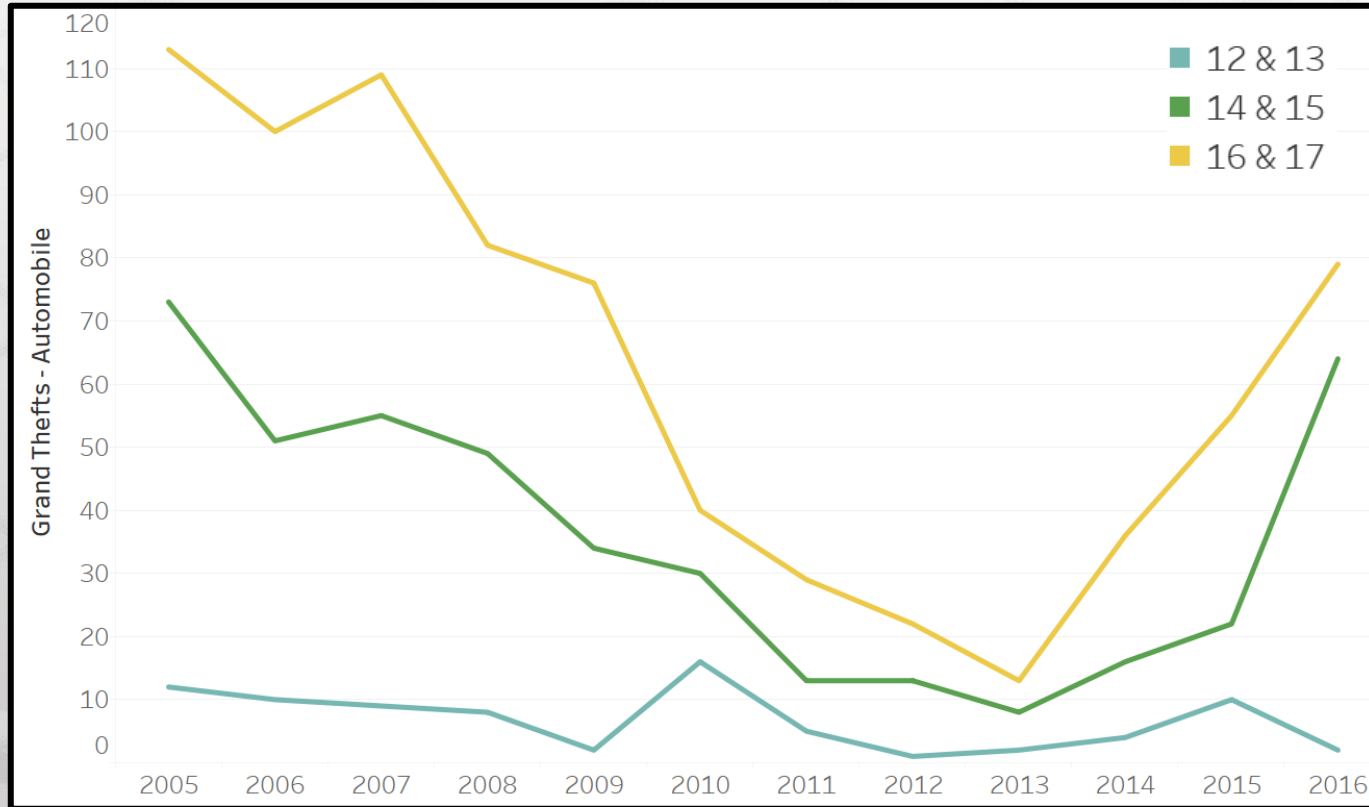


Focusing on the number of crimes within selected ZIP Codes, we see steady decreases from the high numbers seen between 2005 and 2009, with slight upticks in the most recent years.

Number of Juveniles by Gender and Crime Type



Timeline of Grand Thefts – Automobile



The number of grand theft auto charges for youth have increased significantly for three years in succession.

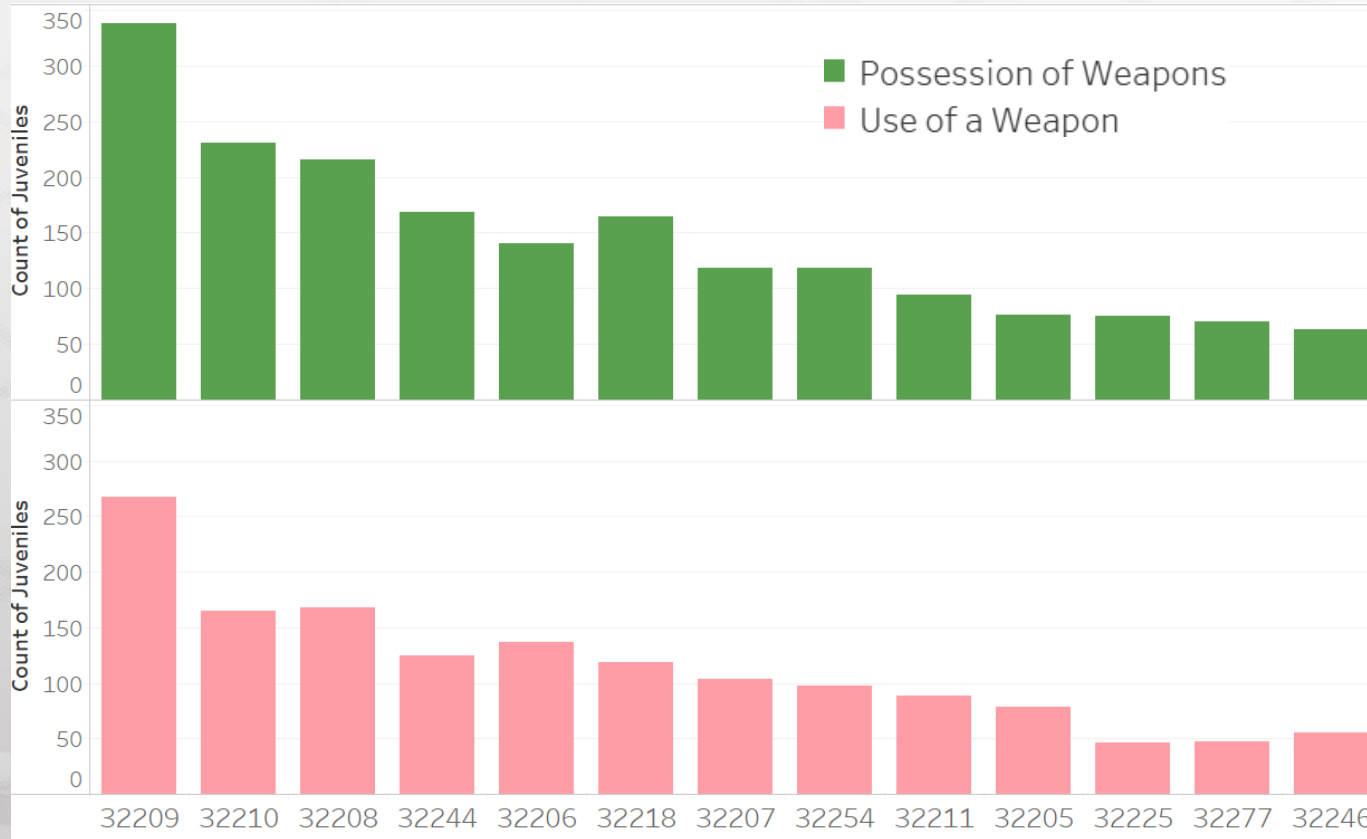
These increases are limited to youth 14 and older.

Timeline of Weapons Charges



Since 2013, possessions of a weapon by a juvenile have more than doubled from 113 occurrences to 237 occurrences. Juvenile use of weapons has also increased from its low point at 2013.

Location of Weapons Charges



32209 has the highest prevalence of juveniles involved in both types of weapons offenses.

Recommendations

- Develop a metric that heavily incorporates Juvenile data for determination of Jax Journey footprint.
- Investigate further the final dispositions of juveniles.
 - Identify when and where diversions are occurring
 - Consider recidivism
- Identify program coverage for 32210 and 32244.
- Identify and evaluate juvenile programs that are gender specific.
 - Evening Report Center is male specific
