**Call to Order/Verify Quorum**: Chair Keeley called the May 2024 GAB CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a quorum was present.

#### Pledge of Allegiance

**Approval of the Previous Meeting Summary** – Approval of the April 2024 meeting summary was completed.

Presentation(s): David Dunkley Jr., Environmental Administrator, Jacksonville Aviation Authority and David Martin, ISA Certified Arborist, Sanford Tree Service informed the CPAC about the upcoming tree removal at Jacksonville Executive at Craig Airport (JAXEX).

Mr. Dunkley informed the CPAC that the removal of trees is necessary to stay in compliance with the Federal Aviation Administration (FAA) tree height regulations. Every airport is required to maintain and prioritize clear approach and departure surfaces and to ensure there is a clear flight path during these critical phases of flight. It has been identified that on the JAXEX property (at the corner of St. Johns Bluff Road N and Monument Road) there are 32 trees that have exceeded FAA tree height regulations.

Mr. Martin from Sanford Tree Service introduced himself and explained the process Sanford Tree Service plans to use to bring the trees into compliance. All the tree height reduction work will be completed Monday through Friday, 8:30 am to 4:30 pm and will be incompliance with the City of Jacksonville traffic and noise ordinances. Height reduction techniques and the use of the tree material as forestry mulch was discussed. It was stated that there will still be a 50-foot tree buffer in the area where the tree height reduction will occur.

There were numerous questions answered and a discussion was held on the techniques that will be used to address the tree heights.

JSO - Lieutenant Terrell presented the following JSO report for District 2:

- In the past 30 days:
  - o There were 243 incidents of crimes against persons, which is down 1 incident from the prior 30 days.
  - There were 421 incidents of property crimes, which is up 14 incidents from the prior 30 days.
  - o There were 406 incidents of crimes against property, which was down 22 incidents from the prior 30 days.
- The crime statistics were broken down by the various JSO subsectors in the GAB District.

### Municipal Code Compliance Division (MCCD) - Robert Bautochka shared the following updates:

- In the past 30 days, 966 inspections were completed, and 177 snipe/litter signs were removed.
- A proactive inspection was conducted on Fort Caroline Road (began at University Boulevard North and ended at Townsend Boulevard) and 19 new cases were generated.
- It was stated MCCD has limited ability enforcing commercial vehicles violations. The
  types of commercial vehicles that MCCD can enforce in residential areas include semitrucks, flatbed trucks, box trucks, and dump trucks to name a few. Pickup trucks and
  vans (with signage on them) are not considered commercial vehicles or a violation to
  parking in a residential area.
- Florida Senate Bill 60 prohibits code inspectors from initiating investigations of potential
  violations of codes and ordinances by way of anonymous complaints. The tickets will be
  closed if they are submitted anonymously.
