Call to Order/Verify Quorum: Chair Keeley called the January 2025 GAB CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a quorum was present.

Pledge of Allegiance

Approval of the Previous Meeting Summary – The November 2024 and December 2024 meeting summaries were approved by the CPAC.

Presentation(s): John Sapora, Housing Resiliency Program Manager, LISC Jacksonville presented on Heir's Property.

Heir's property is property that is inherited without a will, estate plan, or court document from the owner who has passed away, causing unclear or disputed legal title ownership for the descendants.

If the title of the home remains in the deceased family members' name, it is difficult to prove ownership. Those that remain living in the home are legally considered tenants, even if they continue to pay taxes and the upkeep of the property. Proof of ownership is required to access home equity loans, tax rebates, homestead exemptions and disaster recovery assistance. Essentially, Hiers' Property prevents heirs from true homeownership and from passing the property down to future generations. This also leaves the property vulnerable to real estate developers who can acquire the land.

The presentation briefly discussed probate, intestate succession, and educated the CPAC about a Lady Bird Deed. In Florida, a Lady Bird Deed is a type of enhanced life estate deed allowing property owners to retain control during their lifetime while naming beneficiaries to inherit the property upon their death. It bypasses probate and protects Medicaid eligibility and enables the owner to sell or change beneficiaries without the beneficiaries' consent.

Through LISC, Three Rivers Legal Services can help people resolve Heir's Property through legal services. Applications for LISC/ Three River Legal Services were available for those that need assistance.

Elected Officials Report:

The Honorable Matt Carlucci, At-Large, Group 4 and Dylan Reingold, Office of General Council informed the GAB CPAC about Ordinances 2025-0001 and 2025-0002. The following information was discussed.

Council member Matt Carlucci informed the CPAC that the monthly fee for solid waste removal fee has remained at \$12.65 for the past 15 years, but the actual cost is \$30.40. To cover the deficit the city has been borrowing the money through a loan from the city general fund. The city's annual loan payment rose from about \$3 million in 2017 to about \$36 million in 2024. If this issue is not addressed, the loan is on track to surpass \$500 million by 2031.

To correct this issue, Councilmember Matt Carlucci introduced two pieces of legislation, Ordinances 2025-0001 and 2025-0002. Ordinance 2025-0001 would increase the fee to residents, and Ordinance 2025-0002 will create an exemption for low-income individuals and families.

After a lengthy discussion concerning both ordinances, a motion was made to send a letter stating their support for both the ordinances that Council member Carlucci has filed.

The motion was approved unanimously.

The Honorable Ken Amaro, District 1, reiterated that the solid waste fee has been flat since 2010, and we need to address this issue. He looks forward to conversations to determine what is the best way to correct this problem.

Council member Amaro also stated that he has great concern pertaining to Ordinances 2024-0868, 2024-0869 and 2024-0870. The council member stated he understands the importance of creating affordable housing but does not agree with how these ordinances are written and requested that City Council District 1 be removed and not included in the designed area of these ordinances.

Municipal Code Compliance Division (MCCD) - Robert Bautochka shared the following updates:

- In the past 30 days, 745 inspections were completed, and 330 snipe/litter signs were removed.
- A special small inspection project will be conducted in the Monterey area soon.
- Supervisor Bautochka reviewed a portion of Chapter 518, Jacksonville Property Safety and Maintenance Code; Sec. 518-415. All fences on property covered by this Chapter

must be kept in good repair, free from accident hazards, and shall be protected by paint, preservative or weather-resistant material. Fences constructed of noncorrosive metals or decay-resistant species of wood such as cypress and cedar are not required to be painted. It was noted that the City of Jacksonville does not require homeowners to have a fence unless they have a swimming pool. If you see a fence that is in disrepair, please call 630-City or enter a concern into MyJax, Code Compliance can inspect to see if the fence is a violation.

Planning and Development Department – Connor Corrigan – provided an update regarding the LUZ letters generated at the December 2024 CPAC meeting. The CPAC letter requesting a deferral for an application on Forest Boulevard until a traffic study could be reviewed was approved by the Planning Commission. The Transportation Division stated that the segment of Forest Boulevard, near the proposed project, is operating at 15% capacity and that additional vehicles would not adversely affect traffic. The second letter for 2024-0922, an application for proposed townhomes at Townsend Road and Fort Caroline Road has been deferred. There will be a town hall meeting to discuss this project. Mr. Corrigan reviewed Ordinances 2024-0868, 204-0869 and 2024-0870 with the full CPAC and answered questions to the best of his abilities.

Subcommittee Reports (3-minute time limit):

LUZ (Land Use and Zoning)/Governmental Affairs – Mike Corcoran stated the subcommittee did not review any new LUZ applications at the subcommittee meeting earlier, but they did discuss the three Ordinances that Mr. Corrigan just shared with the CPAC. After a lengthy discussion, the LUZ Subcommittee prepared a motion to present to the full CPAC.

The motion presented states:

• Denial of 2024-0868, 2024-0869 and 2024-0870 because these proposed bills are clear attempts to add more people into smaller spaces originally zoned for single-family homes. These proposed ordinance changes are in direct conflict with the Greater Arlington/Beaches Vision Plan which requires all proposed development be of a complementary nature, to advance and elevate the quality of its immediate and adjacent properties. These changes are an attempt to circumvent the Greater Jacksonville Vision Plan and does not maintain a similar characteristic of the surrounding dwellings, nor does it match the existing neighborhood scale of character.

All three of these proposals ignore the effect on the value of the surrounding single-family homes by increasing the volume of traffic in the affected neighborhoods, increasing the amount of crime that always follows the addition of multifamily units into single family neighborhoods which ultimately negatively affects the peace and tranquility of those communities.

Proposed Ordinance 2024-0870 is nothing more than an attempt to put more units into an already small plot of land.

The Greater Arlington/Beaches communities are vehemently opposed to these changes expressing concerns about the already dangerous traffic, child/pedestrian safety issues and will increase exponentially if these changes are approved. It is the unanimous decision of the CPAC that this project is not in the best interest of the existing community or Jacksonville as a whole.

The motion passed unanimously

Chair Keeley reminded the CPAC that he previously shared with the CPAC a letter he received from Kathleen Collins that did acknowledge all the CIP projects that are funded; none of the CIP recommendations that the GAB CPAC submitted were funded. Everyone was encouraged to think of new projects that meet the established criteria. Please share your new CIP recommendations at the February 10, 2025, CPAC meeting.

Chair Keeley introduced new CPAC member JoAnne McIntosh, representing Ashley Green HOA and presented her with an appointment letter from Mayor Deegan and a new member packet.

Public Comment -

Member Donnie Oulton encouraged the CPAC members to attend the Planning Commission meetings and City Council meetings. Mr. Oulton stressed the importance of attending these meetings when your community is concerned about new projects.

Visitor John Nooney introduced himself to the CPAC, described the location of his home and expressed his desire to have additional kayak launches. Mr. Nooney shared that he attends the Jacksonville Waterways Commission meetings, the FINE Commission meetings and the Northeast Florida Regional Council meetings.

Visitor Ed Radloff stated that he did attend the City Council LUZ meeting. At the meeting, Council member Diamond strongly supports the zoning ordinances that he submitted (2024-0868, 2024-0869, 2024-0870, these proposed ordinances have a lot of citizens writing to their council members in opposition. Mr. Radloff reminded the CPAC that he does live in an HOA, and they are actively fighting two proposed townhome communities near his neighborhood.

Motion to Adjourn – there was a motion and a second; the meeting was adjourned.
