Call to Order/Verify Quorum:

Chair Griffin called the SE CPAC meeting to order at 6:30 pm and welcomed everyone to the meeting at the Mandarin Senior Center. Rosemary Wesolowski verified that a quorum was present.

Approval of the Previous Meeting Summary – The July 2024 meeting summary was approved.

Presentation(s): Tiffany Morales, Military Affairs and Veterans Department (MAVD), discussed the services, events and opportunities offered through the MAVD.

Services offered through Military and Veterans Affairs Department include:

 Veterans Services: staff can assist veterans, widows and surviving children with filing a VA claim, identifying benefits, completion and filing paperwork, and advocate on the

- veteran's behalf. Additionally, they can provide help with pre-determination burial for the national cemetery; VA home loan programs, and DD Form 214, Discharge Papers and Separation documents among other services.
- Social Services: Thanks to the Jaguars Foundation, MAVD assists Veterans with housing and utilities through either no-interest loans, grants, and budget counseling. The Jacksonville Veterans Resource and Reintegration Center (JVRRC) can assist with employment. They also offer the Homeless Veterans Reintegration Program.
- Outreach: Services are provided through the Career/Veterpreneur Summit; free yearly tax filing; free monthly legal services; and support through the website, phone calls or offices visits.
- Advocacy: The MAVD manages up to \$4 million in local, state, and federal grants at any
 one time.
- Encroachment Protection/Compatible Land Use Program: this is a program that encompasses 1,770 acres of land that surrounds our local military bases. This program can assist the community with concerns/complaints about military bases, aircraft noise and other issues, such as safety and environmental impacts to land uses around airports.
- Jacksonville was designated a Purple Heart City in June 2024.
- Special Events: These events include the Homeless Veteran Stand Down; Military Spouse's Night Out; Memorial Day Observations and the Veterans Day Parade to name a few.
- Food Farmacy is offered twice a month at the Mayport USO.
- The military flags that are currently displayed in front of City Hall (in James Weldon Johnson Park) will be relocated and mounted to the front of City Hall in the near future.
- There are plans in the next few years to open a Veterans Community Wellness Center in the Emerald District (near Hogan's Creek).

Elected Officials Report:

The Honorable Michael Boylan, City Council District 6 provided the following updates:

- City Council is actively working on the budget review process and will vote to approve the budget at the September 24, 2024, meeting.
- City Council District 6 Town Hall meeting will be held at the Mandarin Senior Center, 3848 Hartley Road on September 25, 2024, at 6:00 pm. Everyone was invited to attend.
- Orange Picker Road & Alberts Field update: the southbound Brady Road stop bar has been relocated closer to the intersection to provide a better view of the oncoming vehicles on Orange Picker Road. The "turn ahead" warning sign was relocated.
- Mandarin drainage issues continue with all the recent rainstorms. Everyone was
 encouraged to report flooding by creating a service request ticket by either calling the
 (904) 630-CITY (2489) or filling out a ticket at <u>WWW.myJax.com</u>.
- City Council has approved the Community Benefits Agreement with the Jacksonville Jaguars, setting in motion a total of \$300 million in funding over the course of the team's 30-year stadium lease, to be split 50-50 between the team and taxpayers. Of the city's portion, \$40 million will be designated for the Eastside neighborhood; this neighborhood is located next to EverBank Stadium.

- In Council District 5, Council Member Joe Carlucci hosted a community meeting at the DuPont Family YMCA, 7373 Old Kings Road, 32217 at 6:00 pm on August 14, 2024. The discussion addressed flooding issues throughout the district and the future development of the YMCA.
- Council Member Joe Carlucci met with the COJ Public Works Department and the Haskell Corporation to get an update on the LaSalle Street Pump Station; phase 1 is near completion.
- There was some discussion about the process of obtaining some speed bumps in a community. Everyone that is interested in adding speed bumps to their community should reach out to their City Council member.

- Council member Arias is working with Duval County Public Schools to improve the safety
 for children attending Bartram Springs Elementary School. The safety improvement plan
 is to add four new signs that have rapid flashing beacons to aide in pedestrian crossing
 and traffic control.
- Another significant traffic concern is at the Wells Creek community on Phillips Highway.
 Councilman Arias is working with JSO to provide traffic control measures while the community waits for a traffic light to be installed.
- There was discussion regarding road conditions on Burnt Mill Road, with a request to have all the lanes repayed. It was noted and the concern will be investigated.

Staff Reports:

JSO - Assistant Chief Glossman provided the following report:

- In the past 30 days:
 - o Crime against persons were down by six incidents
 - No murders occurred in this zone.
 - o There was a decrease in crimes against property; down 34 cases
 - o The amount of burglary and theft cases continues to decline.
- Motor vehicle burglaries and motor vehicle thefts continue to be a problem. This is
 attributed to the thefts of Kia and Hyundai vehicles. If you own one of these brands of
 vehicles, it is highly recommended by JSO that the owner take the vehicle to a local
 dealer to get a software update. This update can assist in reducing the chance of theft.
- To help combat the Kia/Hyundai car theft issue, for a limited time, Kia and Hyundai vehicle owners can come to the JSO District Three Substation to receive a free steering wheel lock. The District Three Substation is located at 8875 Liberty Ridge Drive, Suite 110, Jacksonville, FL 32256; please visit between the hours of 8 a.m. to 5 p.m., Monday Friday. To receive the steering wheel lock, you will need to show your I.D. and complete a form. For more information, please call 904-630-8100.
