

Small scale land use amendment application <u>L-5797-23C</u> was amended and re-referred through the public hearing process by City Council on <u>October 22, 2024</u>, as <u>Ordinance 2023-325</u>.

The subject site is approximately <u>33.95 acres</u> and is located with the address of <u>0 Brandy Branch Road</u>, on the south side of Brandy Branch Road, west of Canal Street.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Agriculture (AGR)</u>. Plan category descriptions can be found on the Planning and Development Department website.
