

### Notice of Public Hearing for Proposed Land Use Change

Small-scale land use amendment application <u>L-5886-23A</u> was filed on <u>June 5, 2024</u>, as <u>Ordinance 2024-454</u>.

The subject site is approximately <u>1003.9 acres</u> and is located with an address of <u>0 Pecan Park</u> <u>Road and 0 Main Street North, between Interstate 95 and Main Street</u>.

The current land use category is <u>Multi Use Pursuant to SSP 4.3.15 (MU) and Light Industrial</u> (<u>LI</u>). The proposed land use category is <u>Low Density Residential (LDR)</u>, <u>Medium Density</u> <u>Residential (MDR)</u>, <u>Community General Commercial (CGC)</u>, <u>Light Industrial (LI) and</u> <u>Conservation (CSV)</u>.
