



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5932-24C was filed on July 17, 2024, as Ordinance 2024-529.

The subject site is approximately 9.29 acres and is located with an address of 0 Jammes Road, between 118th Street, and Hannah Stables Drive.

The current land use category is Neighborhood Commercial (NC). The proposed land use category is Community / General Commercial (CGC). Plan category descriptions can be found on the Planning and Development Department website.
