

## Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5939-24C</u> was filed on <u>July 17, 2024</u>, as <u>Ordinance 2024-529</u>.

The subject site is approximately <u>9.29 acres</u> and is located with an address of <u>0 Wingate Road North</u>, between Wingate Road North and Dobson Drive.
