



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5940-24C was filed on June 18, 2024, as Ordinance 2024-480.

The subject site is approximately 1.00 acres and is located with an address of 9320 Garden Street, between Sierra Oaks Boulevard and Golden Bamboo Drive.
