Small scale land use amendment application  $\underline{\text{L-5942-24C}}$  was filed on  $\underline{\text{November 20, 2024}}$ , as  $\underline{\text{Ordinance 2024-902}}$ .

### PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS
