



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5943-24C was filed on July 17, 2024, as Ordinance 2024-526.

The subject site is approximately 0.99 acres and is located with an address of 3319 Lenox Avenue, between Nelson Street and Summer Street.

The current land use category is Residential Professional Institutional (RPI). The proposed land use category is Business Park (BP). Plan category descriptions can be found on the Planning and Development Department website.
