



## **Notice of Public Hearing for Proposed Land Use Change**

Small scale land use amendment application L-5946-24C was filed on July 17, 2024, as Ordinance 2024-518.

The subject site is approximately 23.70 acres and is located with an address of 0 Palm Lake Drive, between Eastport Road and Palm Lake Drive.

The current land use category is Light Industrial (LI) and Business Park (BP). The proposed land use category is Medium Density Residential (MDR). Plan category descriptions can be found on the Planning and Development Department website.
