

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5947-24C</u> was filed on <u>June 18, 2024</u>, as <u>Ordinance 2024-482</u>.

The subject site is approximately <u>0.15 acres</u> and is located with an address of <u>6721 Norwood Avenue</u>, <u>between Essex Street and Laurel Street</u>.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Community/General Commercial (CGC)</u>. Plan category descriptions can be found on the Planning and Development Department website.
