



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5947-24C was filed on June 18, 2024, as Ordinance 2024-482.

The subject site is approximately 0.15 acres and is located with an address of 6721 Norwood Avenue, between Essex Street and Laurel Street.

The current land use category is Low Density Residential (LDR). The proposed land use category is Community/General Commercial (CGC). Plan category descriptions can be found on the Planning and Development Department website.

PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS
