



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5955-24C was filed on July 17, 2024, as Ordinance 2024-531.

The subject site is approximately 0.52 acres and is located with an address of 8363 Ramona Blvd. West, between Hammond Blvd., and Cahoon Rd.

The current land use category is Neighborhood Commercial (NC). The proposed land use category is Community / General Commercial (CGC). Plan category descriptions can be found on the Planning and Development Department website.
