

### Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application  $\underline{\text{L-5959-24C}}$  was filed on  $\underline{\text{September 25, 2024}}$ , as  $\underline{\text{Ordinance 2024-785}}$ .

The subject site is approximately <u>0.09 acres</u> and is located with addresses <u>0 Beach Boulevard</u>, <u>between</u> Beach Boulevard and Big Pottsburg Creek.

#### PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS

- Host will ONLY recognize speakers that use the ELECTRONIC "RAISE HAND" feature located within the Zoom App \*9 ... wait to be recognized. (Must have a Microphone and Speakers on phone to participate with the function.)
