

### Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application  $\underline{\text{L-5971-24C}}$  was filed on  $\underline{\text{September 25, 2024}}$ , as  $\underline{\text{Ordinance 2024-787}}$ .

The subject site is approximately <u>38.47 acres</u> and is located with addresses <u>0 Moncrief Road and 6739 Utsey</u> Road, between Moncrief Road and Utsey Road.

The current land use category is <u>Agriculture (AGR)</u>. The proposed land use category is <u>Light Industrial (LI)</u>. Plan category descriptions can be found on the Planning and Development Department website.

#### PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS
