

### Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application  $\underline{\text{L-5972-24C}}$  was filed on  $\underline{\text{November 6, 2024}}$ , as  $\underline{\text{Ordinance 2024-859}}$ .

#### PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS
