

# Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5976-24C</u> was filed on <u>September 25, 2024</u>, as <u>Ordinance</u> <u>2024-789</u>.

The subject site is approximately <u>9.94 acres</u> and is located with an address of <u>0 Jennings Road</u>, between Ross Boulevard and Jennings Road.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Medium</u> <u>Density Residential (MDR)</u>. Plan category descriptions can be found on the Planning and Development Department website.
