

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5984-24C</u> was filed on <u>November 20, 2024</u>, as <u>Ordinance</u> 2024-908.

The subject site is approximately <u>8.95 acres</u> and is located with an address of <u>0 Newton Road and 0 Cargal Street</u>, between Beach Boulevard and Southside Boulevard.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Medium Density Residential (MDR)</u>. Plan category descriptions can be found on the Planning and Development Department website.

PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS

The following commands can be entered via phone tones using your phone's dial pad while in a Zoom meeting:
