Ordinance #: 2024-517

Large-Scale Text Amendment: Amendment to the Coastal High Hazard Areas and

Hurricane Evacuation Zones Map of the Future Land Use Map Series from the 2045 Comprehensive Plan.

Text Amendment Issues:

Section 163.3179, Florida Statutes requires designation of coastal high-hazard areas (CHHA) in the local comprehensive plan. The statute defines the CHHA as the area below the elevation of the category 1 storm surge line as established by a Sea, Lake, and Overland Surges from Hurricanes (SLOSH) computerized storm surge model. The SLOSH model for northeast Florida is periodically updated by the Northeast Florida Regional Council and this amendment updates the map consistent with the most recent data.
