

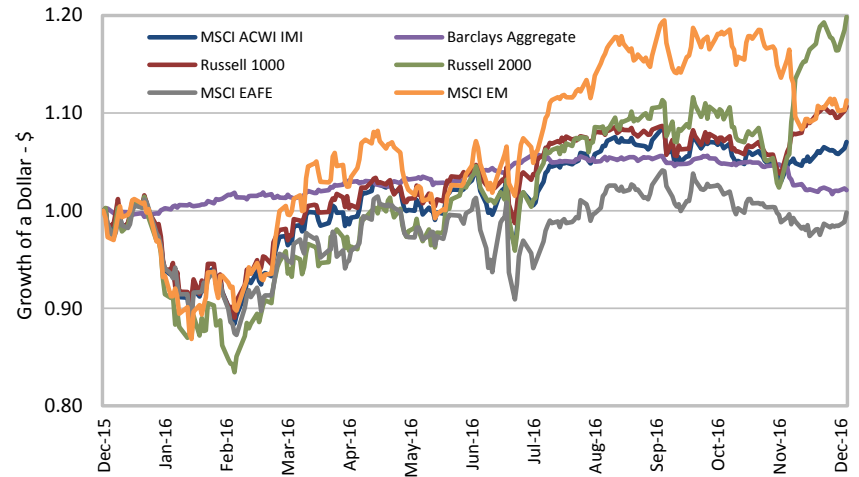

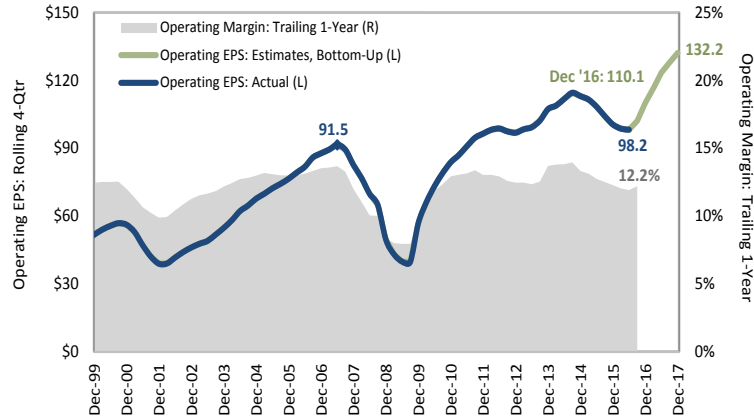

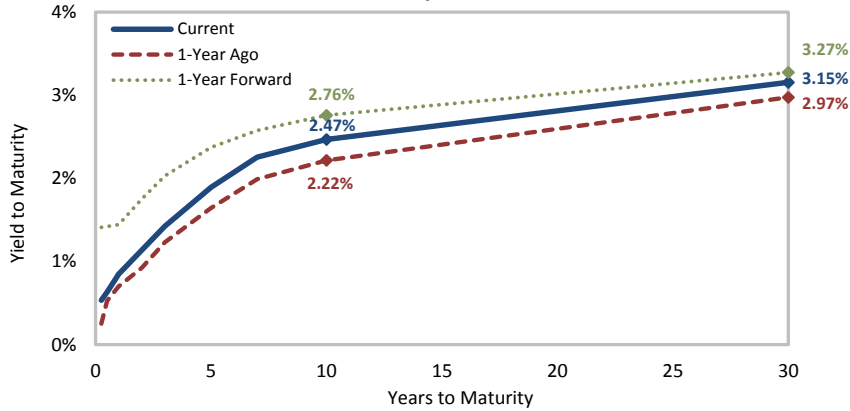

Treasury Yield Curve



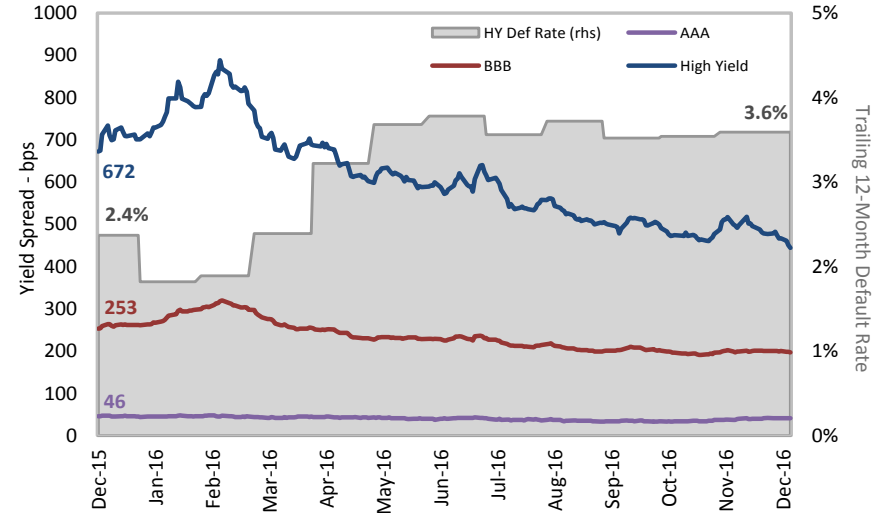

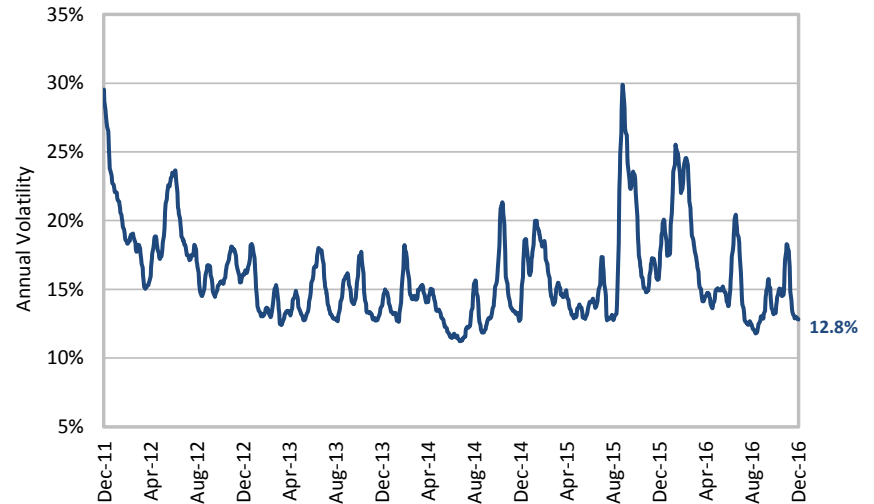
U.S. Dollar vs 6 Major Currencies
