- A. Meeting was called to Order by Chair at 12:02 PM.
 - **1.** All present introduced themselves for the record.
 - **2.** Submittal of Speaker's Cards.
 - **3.** Motion made by Mr. R. Robinson, seconded by Mr. Flagg, for approval of minutes from January 10, 2019 meeting. None opposed.
 - 4. Fund balance and encumbrance report for 15(F), 15(N) and BJP (Attachment A) Joel Provenza.
 - a. CM Crescimbeni told the Commissioners to expect a \$1.3 million contribution from JEA to the Tree Fund for mitigation during the installation of a high-volume transmission line from the Bayard area to Racetrack Road.
 - 5. Status of Pending Tree Projects (Attachment B) Kathleen McGovern.
 - a. A non-mandatory, pre-bid meeting had good turnout (approximately seven contractors) for the Mandarin and Springfield Projects. The bids open on February 6th. The RAP re-leaf is in legislation.
 - 6. Status of Countywide Tree Planting Contract Dave McDaniel
 - a. The RFP is at the Procurement Division and will be advertised no later than January 30th. The bid will be open and available for pick up for 30 days after the opening on Janurary 30th. CM Crescimbeni asked if anyone follows up with the contractors that pick up a bid but do not submit one. Mr. McDaniel said he believes the Procurement Division follows up. **CM Crescimbeni said he would contact Greg Pease, the Procurement Division Chief, and ask about follow-up or surveys**.
 - b. Mr. R. Robinson asked if the bid was selected by lowest bid, qualifications, or a combination of both.
 Mr. McDaniel said there are minimum qualifications in the bid package that must be met. If they do not meet those requirements they could be disqualified, no matter how low their bid is.

B. New Business

1. Community Tree Planting Program Level 2 legislation – Susan Grandin. Deferred until next meeting.

- Community Tree Planting Program Level 3 instructions (Attachment C) and application (Attachment D) Susan Grandin
 - a. The items that were added were further items for Exhibit D: scope of work and performance schedule.
 - b. CM Crescimbeni asked for scope of work to be defined or examples given. Ms. MsGovern suggested some of the examples could be a summary of the installation, maintenance, or soil removal. Ms. Grandin will add a description or examples and circulate the update.
- 3. Community Tree Planting Program Level 3 grant agreement (Attachment E) Lawsikia Hodges
 - a. The word 'grant' has been stricken as there will be payments made to the signatory.
 - b. Article I –Definitions the City Tree Planting standards and specifications has been defined as the landscape specifications and planning details which will be attached to the agreement. Also, 'eligible grant expenditures' has been deleted.
 - d. The first paragraph for Article IX, Financial Reporting, has been removed. This requirement is associated with City grants.
 - e. The list of exhibits has been updated to match the application.
 - f. Exhibit G-2 Draw Request form will be completed by the recipient and turned into the contract administrator: the City arborist. Article XII explains this and will be added to the form.
 - g. Mr. Flagg asked about the second bullet on exhibit E, regarding who is authorized to design a tree planting project. Specifically, landscape architects are licensed, which means a greater liability responsibility whereas the rest listed are not. Mr. M. Robinson added that urban foresters are not licensed by the State; arborists are certified and that requirement should be added. Ms. Grandin or Ms. Hodges will restructure the sentence to read 'be designed by a qualified professional such as', remove 'registered' from before 'landscape architect', add 'certified' before 'arborist' and replace 'right-of-way' with 'public'. Also to be added to Article III, 3.2 "All projects will be reviewed by a City landscape architect." Third and fourth bullets need to be changed to "a period of up to two years."
 - h. Ms. Dooley asked about the sixth bullet point regarding the requirement to request three bids. CM Crescimbeni pointed out that if you do not want to get the three bids, you may use the City contractor. Mr. November added that he thought the requirement was to show three bids had been requested, not necessarily received. Ms. Hodges pointed out that, from a Procurement prospective, bids must be received and not just requested. Ms. Dooley added that there is no guarantee they will get three bids back. Mr. R. Robinson added that he has never had to get bids from subcontractors. Ms. Hodges suggested "major suppliers" be stricken. CM Crescimbeni suggested the bullet be rewritten to clarify that three bids must be requested. However, if only one response is returned with two no bid responses, this requirement has been satisfied.
 - i. Mr. November requested that the Tree Commission's ability to waive the restriction to plant trees only listed on the Approved Tree Planting List be added to bullet seven of exhibit E, as well as waiving the requirement to only plant Florida Fancy or Florida #1 trees. The request for a waiver should be made prior to the submission of the application. Ms. Hodges will add "or as previously approved by the Commission" to bullets seven and eight. Ms. Grandin will add language to the instructions for the applicant to come before the Tree Commission Staff prior to the submission of the application to discuss their conceptual and preliminary ideas (Section IV, E), especially if they are requesting any type of waiver.
 - j. Mr. November questioned the approved draw schedule. This is an agreement between the City and the contractor. The only thing definite is the initial draw and the final draw. What about in between? Ms. Hodges envisioned the draw schedule would have some milestones, which may differ from project to

project. CM Crescimbeni pointed out that this needs to be flexible and as the City is paying reimbursement, there is no risk. The draw schedule will be determined by the contract administrator.

- Application, item C.4. Mr. November questioned the rationale for selecting the winning contractor, subcontractor and/or supplier. Those won't be selected until after the application has been approved.
 Ms. Grandin will strike this item and re-number.
- I. Mr. R. Robinson put forth a motion to approve the Level 3 application, instructions and agreement to include the discussed changes. Mr. Flagg seconded the motion, which passed unanimously.
- **4.** Penalties for cutting down trees with no permit and incorrect pruning (Attachment F) Susan Grandin & M. Robinson
 - a. Mr. M. Robinson said there have been two meetings regarding these issues. This process is ongoing.
 CM Crescimbeni requested the Commissioner's read Attachment F and bring any questions or comments to the next meeting.
- 5. Plan-it GEO Watering Tracking Module Evaluation Dave McDaniel
 - a. Mr. McDaniel, Mr. Leon and Ms. McGovern reviewed the module. They concluded that is it is very easy to use, however it would be more of an in-house function rather than allowing Level 3 groups to input their project's watering schedules.
 - b. One possibility that has been discussed is the Mowing and Landscape Division purchasing a watering truck with tree funds. The question is always raised: How do we know the truck will only be used to water trees that have been purchased by the Tree Fund? Mr. Leon pointed out that 25% of the Mowing and Landscape Division's budget comes from 15F, earmarked for maintenance of trees on the right-of-way, not just trees that were planted using tree funds. Purchasing a watering truck (using tree funds) would solve many of these issues.
 - c. Ms. McGovern agreed; she could be successful tracking the delivery of water from the water truck using this module.
 - d. CM Crescimbeni asked Ms. Grandin to determine if using 15F funds to purchase, operate, and maintain a water truck/trailer would be allowed.

C. Public Comment

John November – 1) The City Council will need some education on the Tree Commission's community planting program. 2) The first application cycle is currently listed as May 1^{st} and perhaps the Tree Commission should open the program on March 1^{st} or April 1^{st} . Now that the application is complete, they need to begin the outreach process to get the word out so they have a diverse set of applicants for both the Level 2 and Level 3 applications. 3) If Ms. Grandin could define more specifically what "incidental landscaping" means, that would provide some guidance to contractors.

Tracey Arpen – The Riverplace road diet project has planted lovely Live Oaks in a four foot round planting hole surrounded by impervious concrete. Is it too late to request a change order to put in an eight-foot, square hole so the Live Oaks will have a chance to thrive? **Mr. Pappas said he would look at the design to see if there is anything that can be adjusted.** Mr. Flagg added that he understands it is very difficult to amend already approved plans, but when planting Live Oaks, they must have sufficient room. CM Crescimbeni asked if pervious concrete would help. Mr. Flagg said it would. CM Crescimbeni suggested updating the Ordinance Code to say that you can have a four-foot opening, but if you are planting a Live Oak, any surface within X feet of the opening must be pervious. Ms. Grandin added that was already in the Ordinance Code for developers but it

doesn't necessarily say it applies to the City. Mr. Flagg said he would have liked for that to have been handled by the Downtown Development Review Board because there were two landscape architects on that board. **CM Crescimbeni suggested the Commissioners try to fix that going forward.**

CM Crescimbeni thanked everyone in the audience for participating in this process. There is now a Remove and Replace program, and Level 1, 2 and 3 programs. With regard to the roll-out, he's had conversations with the Mayor and they are going to be cautious about rolling out anything that's unfunded at this point. They are prepared to discuss Remove and Replace and the Level 1 program. The legislation for Level 2 will be introduced at the next Council Meeting. Until they get the continuous contract situation resolved, the Mayor's office wants to be cautious about broadcasting. If the Public Trust or Greenscape have an interest in submitting a project, they may do so. Ms. McGovern is receiving calls on both Level 1 and Level 2 projects. When everyone is ready, there will be a joint press conference between the Tree Commission and the Mayor to generate some publicity.

D. Action Items

CM Crescimbeni will contact Greg Pease, Procurement Division Chief, and ask about follow-up or survey for contractors who pick up bids but do not submit.

Instructions IV.D.6 - Ms. Grandin will add a description or examples of the scope of work and circulate the update.

Instructions IV.E - Ms. Grandin will add language for the applicant to come before the Tree Commission Staff prior to the submission of the application to discuss their conceptual and preliminary ideas, especially if they are requesting a waiver.

Application - Ms. Grandin will strike C.4 and re-number.

Agreement Exhibit E, 2nd bullet - Ms. Grandin or Ms. Hodges will restructure the sentence to read 'be designed by a qualified professional such as', remove 'registered' from before 'landscape architect', add 'certified' before 'arborist', and replace 'right-of-way' with 'public'. Also to be added to Article III, 3.2 'All projects will be reviewed by a City landscape architect'.

Exhibit E, 3rd and 4th bullets – Ms. Hodges will add 'a period of up to two years' to each bullet.

Exhibit E, 6th bullet - Ms. Hodges suggested 'major suppliers' be stricken. CM Crescimbeni suggested the bullet be rewritten to clarify that three bids must be requested, but if only one response is returned with two no bid responses, the requirement has been satisfied.

Exhibit E, 7th and 8th bullets - Ms. Hodges will add 'or as previously approved by the Commission' to each bullet.

Commissioners will read the white paper from the Committee on Unauthorized Tree Pruning/Removal (Attachment F).

Committee on Unauthorized Tree Pruning/Removal will determine if an Ordinance Code update allowing a fourfoot opening, but if a Live Oak is being planted, any surface within X feet of the opening must be pervious. Ms. Grandin said that was already in the Ordinance Code for developers but it doesn't necessarily say it applies to the City. Ms. Grandin will determine if using 15F funds to purchase, operate, and maintain a water truck/trailer is allowed.

Mr. Pappas said he would look at the design of the planting holes for the Live Oaks planted for the Riverplace Road Diet project to see if there is any chance of increasing those planting holes.



INSTRUCTIONS

I. Purpose

This document sets forth the procedures and rules that must be followed for grant applications for the Jacksonville Tree Commission's Level 3 Community Organization Tree Planting Program ("Community Organization Tree Program" or "Level 3 Program") utilizing the Tree Protection and Related Expenses Trust Fund. The purpose of the Level 3 Program is to provide grants to local community and not-for-profit organizations for the design, management and implementation of tree planting projects on publically owned land within Duval County for the conservation and enhancement of the City of Jacksonville's ("City") tree canopy.

The Tree Commission is an advisory body that encourages and coordinates the efforts of the various public and private entities that are concerned with the conservation and enhancement of the City's tree canopy. The Tree Commission is the subject matter expert on the City's tree canopy and is tasked with making recommendations to the City Council, Mayor's Office, City Staff, and community stakeholders with respect to the planting of trees and the health of the City's tree canopy. Pursuant to Sec. 94.106, *Ordinance Code*, the Tree Commission was charged with coordination of tree planting projects between public and private entities and to review expenditure proposals and plans for such planting projects. To that end, this Level 3 Program sets a framework for how the City might collaborate with community organizations through the funding of eligible, prioritized projects.

The Tree Protection and Related Expenses Trust Fund, as authorized by Sec.111.760, Ordinance Code, and Sec. 25.04, City Charter ("Tree Funds"), is comprised of funds that are required to be expended on the provision and maintenance of trees and incidental landscaping to such trees on all public lands in Duval County. In an effort to improve the City's tree canopy, the City will collaborate with not-for-profit, and other community organizations to achieve this goal through tree planting projects.

Definitions.

II.

Applicant means an eligible not-for-profit or community organization that submits an Application for Tree Protection and Related Expenses Trust Fund funds through the Tree Commission.

Application Evaluation Period means the period commencing at the time of the Level 3 Program Application Deadline listed In Section VII, and ending at the public meeting at which the Tree Commission submits its scores for calculation.

Award means a grant from the City pursuant to the procedures outlined in this document. Award Session means the schedule reflected in Section VII of this document. Department means the Public Works Department.

Design Consultant means a Landscape Architect, Urban Forester, Arborist, or landscape designer with at least 5 years of experience in the design and administration of tree planting projects on road rights-of-way. Experience must include preparing design documents and bid specifications, obtaining bids, providing contractor oversite, and inspecting the contractor's work. The Design Consultant may be an employee of the Applicant.

City's Continuous Contract means the annual contract awarded by the City to a landscape contractor to provide countywide tree planting and maintenance services. *Grant Agreement* means the agreement between the Applicant and the City setting forth the requirements and responsibilities for the design, coordination, and implementation of a Project.

Project Cost means the total of all eligible costs associated with the design, coordination,
procurement of materials, planting, irrigation, warranty and maintenance of the Project in
accordance with this Instructions document.
Project Design means the compilation of the Schematic Planting Plan drawings and the
construction drawings and specifications for the irrigation and planting of the trees and

Project Priority List means the list created by the Tree Commission for submission to the Mayor's Budget Review Committee ("MBRC") for consideration and approval for legislation to approve the grant.

incidental landscaping prepared by the Design Consultant.

Publicly owned property in Duval County means property owned by a governmental

entity, including, but not limited to land within the City or State right-of-way; local, state or federal parks and preserves; and Duval County School Board property.

Recipient means an applicant that has been approved for funding by the City Council and who has executed a Grant Agreement with the City for an Award.

Schematic Planting Plan means a scaled drawing showing all significant components by means of standards symbols such as the site location map, the limits of the project,

property lines or right-of-way lines, plant legend, and master tree planting plan. *Tree Commission* means the advisory body created in Chapter 94, *Ordinance Code*. *Tree Fund* means the monies within the Tree Protection and Related Expenses Trust
Fund, pursuant to Sec. 111.760, *Ordinance Code*, and Sec. 25.04, *Jacksonville Charter*.

General Requirements and Eligibility Standards.

III.

The following constitutes the general procedures for the Level 3 Program.

- A. Application Form. The application form for the Level 3 Program is entitled "Level 3 Tree Planting Program" and is prescribed for use with these procedures.
 Applications for funding must be submitted on this form, and shall include the completed Exhibits to the application. An applicant may only submit one project. per application form.
- B. Eligible Applicants.
- 1. For 501(c) not-for-profit organizations:
- a) Attach a copy of the organization's IRS determination letter.
 b) Attach a status of good standing certificate issued by the Florida Division of Corporations evidencing that the Applicant is in good standing and has been in existence for one (1) year prior to the Level 3
 Program application deadline. See Section VII of these Instructions for the Application Schedule. The certificate must be dated within 60 days of the application deadline and list the requesting agency as a Florida non-profit corporation (requested from Florida Division of Corporations here: <u>http://dos.myflorida.com/sunbiz/manage-</u>
- c) In order to show that the applicant is currently operating in Duval

 Prior to the submission of an application, Applicants are <u>strongly</u> <u>encouraged</u> to discuss their conceptual and preliminary ideas with the Tree Commission staff.

 Applicants may submit their application to Tree Commission staff for review of <u>completeness</u> of the Application during a courtesy application review period prior to each Application Deadline. See Section VII of these Instructions for the applicable time frames.

Feedback and input from Tree Commission staff may be provided

V. Application Review and Process.

- A. Staff Review. The Tree Commission staff will review and prepare a report and recommendation ("Staff Report") for approval, approval with conditions, or denial that will be sent to the Tree Commission, the District Council Member, and the Applicant. The Staff Report shall be based upon the application and exhibits, and shall include an analysis of each of the Project Evaluation Criteria. The Staff Report will <u>not</u> include a score for each application.
- B. Application Presentation. All applications shall be presented at a scheduled public meeting held by the Tree Commission, for review, deliberation, and final recommendation. Special meetings may be held if needed at the discretion of the Tree Commission.
- Each Applicant shall have 10 minutes to present their application to the Tree Commission at the scheduled public meeting.
- Commissioners shall receive a copy of all applications and Staff Reports at least 14 days prior to Tree Commission meeting when the applications will be heard.
- C. Tree Commission Review. Each application will be scored by the Tree Commission each Award Session, the applications will be ranked in order of highest score and on a each application. the Applicant's presentation for scoring. Each Commissioner will individually score application, including the exhibits, Staff Report and all information obtained during processing through included on a recommended Project Priority List submitted to the Mayor's Office for application, the Tree Commissioners shall utilize the information contained in the projects. - D. Project Priority List. The Assistant General Counsel assigned to the Tree Commission will average the total score for each application from each
 Commissioner to arrive at a final score for each application. The applications will

then be ranked in order of highest average score to the lowest average score, with a total of the funding requested. This ranking will be included in the Tree Commission's Project Priority List to be presented to MBRC for review.

- E. MBRC Review. At the earliest MBRC meeting following the ranking of the proposed projects by the Tree Commission, the Tree Commission staff will submit and present the Project Priority List for review and approval through the MBRC process. If the MBRC approves any or all of the projects as presented, or as modified, the Office of General Counsel will prepare the appropriate legislation and Grant Agreement(s) as directed by MBRC for consideration by the Council for funding. In the alternative, MBRC can decide to delay the funding of a proposed project to a later date or decide not to fund a certain project from the Project Priority List. If a proposed project is denied by MBRC, no further action on it shall be taken on the project through the Level 3 Program, however, this does not limit the ability of a Council Member to file legislation to implement a Project utilizing the Tree Fund.
- F. City Council Review. The legislation containing the Project(s) and Grant Agreement(s) as directed by MBRC will be filed by the Office of General Counsel with the Legislative Services Division for final decision by the City Council of approval, modification, or denial of the project and Grant Agreement, and appropriation of the Tree Funds.
- G. Contract Award. Upon execution of the completed Grant Agreement by all parties, the Applicant will be eligible for payment of funds approved as part of the Project Cost.

Project Evaluation Criteria.

VI.

- A. Design Review 35 point total (5 points each)
- 1. The species of trees are appropriately located.
- 2. The number and placement of trees are appropriately located.
- Trees being planted are approved pursuant to the "Tree Commission Approved Tree Planting List," attached hereto, and as that document is amended from time to time.

- 4. Shade trees are preferred. If non-shade trees are proposed, the use of those trees versus the use of shade trees in terms of the overall project must be acceptable.
- 5. Less than 25% of the total species of trees being planted are palms.
- 6. The planting will not interfere with utilities or sight line requirements.
- 7. The project does not include incidental landscaping. But in the event it does include incidental landscaping, the applicant may justify the reasons for its

inclusion.

- 1. Administrative costs are reasonable.
- 2. Design Consultant fees are reasonable.
- 3. Construction costs are reasonable.
- 4. Irrigation costs are reasonable.
- The cost of the species of trees selected do not outweigh the benefit of the trees
- C. Maintenance and Impacts Review 10 point total (5 points each)
- 1. Low maintenance plants are utilized, that will require minimum maintenance
- after the first two (2) years of mandatory maintenance by the Applicant. 2. The location of plant material and irrigation have a minimum adverse impact
- over time on infrastructure such as sidewalks and roadbeds.
- D. Public Benefit Review 25 point total (5 points each)
- **1.** The species of trees being planted are beneficial to the City's tree canopy.
- 2. The Project provides a unique benefit to the neighborhood, Council District, or City.
- 3. The Project serves high visibility areas.
- 4. The Project engages the Community though volunteers or education or other public engagement.
- 5. The Project is aesthetically pleasing and/or combats blight in blighted areas
- E. Plan-It Geo Objective Criteria Review 20 point total (4 points each) conducted by staff. Staff will utilize the Plan-It Geo Web Tool to evaluate the existing conditions of the proposed planting project location. This does not

include or require uploading the Schematic Design, but rather identifying the geographic boundaries of the project.

1. The location will be evaluated based on the Census Block ranking (1- 488)

developed by Plan-It Geo for the five (5) categories listed below:

- a) Urban Tree Canopy Percentage
- b) Stormwater Benefits
- c) Urban Heat Island
- d) Socio-Economic Benefits
- e) Overall-equally weighted criteria, as stated below:

A maximum of 4 points per category is possible. If a project is on the border of two or more Census Blocks, then the average of the census blocks will be applied to determine a score (e.g. located on the 50th and 300th census blocks, then 175th census block will be applied so that it will receive 3 points). The ranking and corresponding points are as follows:

- (1) 1st-25th percentile (1-122)- 4 points;
- (2) 26th- 50th percentile (123-244)- 3 points;
- (3) 51st-100th percentile (245-366) 2 points
- (4) 76th-100th (367-488) percentile- 1 point

VII.

Application Schedule. The Tree Commission will review and create a recommended Project Priority List for submission to the MBRC for a recommendation to the City Council for project funding three (3) times per year, utilizing the Tree Protection and Related Expenses Trust Fund. The initial application deadline will be as soon as practicable after approval of this Level 3 Program by the Tree Commission. The Tree Commission's review of projects will follow, if possible, the below schedule. All deadlines are 3:00 PM on the specified date below. If a date listed below falls on a weekend or a legal holiday, the operative date shall be the next business day.

TREE PLANTING PROGRAM (LEVEL 3) <u>GRANT</u> AGREEMENT
THIS TREE PLANTING PROGRAM (LEVEL 3) <u>GRANT</u> AGREEMENT ("Agreement") is made and is effective as of, 20 (the "Effective Date"), by and among the CITY OF JACKSONVILLE, a consolidated political subdivision and municipal corporation existing under the laws of the State of Florida (the "City") and (the "GranteeContractor").
RECITALS:
WHEREAS, pursuant to, the Jacksonville Tree Commission (" <i>Commission</i> ") established the Level 3 Community Organization Tree Planting Grant Program (the " <i>Program</i> "), which program provides grantproject funding to local community and not-for-profit organizations to design, manage and implement tree planting projects on publically owned land within Duval County that will conserve and enhance the City's tree canopy;
WHEREAS, the GranteeContractor applied to the Commission to receive grantproject funding under the Program for the tree planting project more particularly described in Grantee's grantContractor's project application; and
WHEREAS, the Commission has approved Grantee's grantContractor's project application request and the City Council pursuant to Ordinance has agreed to fund Grantee's Contractor's tree planting project subject to the terms and conditions provided herein.
NOW, THEREFORE, in consideration of the covenants and agreements set forth in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows.
ARTICLE I Incorporation of Recitals; Definitions
1.1 The parties hereto acknowledge and agree that the recitals above are correct and incorporated herein by this reference.
1.2 All capitalized terms shall have the meanings given to them in this Agreement, including, but not limited to, the capitalized terms defined below:
"Application" shall mean Grantee'sContractor's application under the Program as approved by the Commission, a copy of which is on file with the Commission.
"City Tree Planting Standards and Specifications" shall mean the City tree planting standards and specifications identified in [insert code or manual references] contained on Exhibit F attached hereto.
"Construction Documents" shall mean the Design Plans along with any modifications thereto.

ARTICLE IV Project Performance Schedule

4.1 The GrunteeContractor and the City have jointly established the Project Performance Schedule. The GrunteeContractor shall timely perform its obligations set forth on the Project Performance Schedule. The Project Performance Schedule shall not be modified without the prior written consent of the City, which consent may be withheld in its sole discretion.

ARTICLE V Completion of Project

5.1 <u>Completion of the Project</u>. The <u>GrunteeContractor</u> shall complete construction of the Project Scope by no later than ______, 20___ (the "*Project Completion Date*"). For purposes of this Agreement, completion of the Project Scope shall be deemed to have occurred only when the following conditions (the "*Project Completion Conditions*") shall have been satisfied:

(a) The GranteeContractor shall furnish to the City certificate of substantial completion from the architect to establish to the City's satisfaction that the Project Scope has been properly completed and is not subject to any violations or uncorrected conditions noted or filed in any City department;

(b) The GranteeContractor shall submit to the City a proper contractor's final affidavit and full and complete releases of liens from each contractor, subcontractor and supplier, or other proof satisfactory to the City, confirming that final payment has been made for all materials supplied and labor furnished in connection with the Project Scope;

(c) The Project Scope shall have been finally completed in all respects in accordance with the Design Plans, as verified by a final inspection report satisfactory to the City, certifying that the Project Scope has been constructed in a good and workmanlike manner and is in satisfactory condition. In the event the City determines that there is a deficiency with the Project Scope, the City reserves the right to require that an escrow be established in an amount satisfactory to the City to remedy such deficiency.

5.2 <u>Change Orders</u>. No material amendment shall be made to the Design Plans or the Construction Documents executed in connection with the Project Scope nor shall any material change orders be made by <u>GranteeContractor</u> thereunder without the prior written consent of the City.

5.3 <u>Subcontractors</u>. The <u>GranteeContractor</u> agrees that it will not engage or continue to employ, or permit any of its general contractors to engage or continue to employ, any contractor, subcontractor or materialman or any other third party who may be reasonably objectionable to the City. If requested by the City, the <u>GranteeContractor</u> shall deliver to the City a fully executed copy of each of the agreements between the <u>GranteeContractor</u> and such third parties and between any such general contractor and any contractor, subcontractor or materialman or any other third party, each of which shall be in form and substance reasonably satisfactory to the City. The City's approval of a construction contract is specifically conditioned upon the following: (a) the total contract price thereof does not exceed the fair and reasonable cost of the Project Scope to be performed thereunder and (b) the contractor or subcontractor is of recognized standing in the trade, has a reputation for complying with contractual obligations and is otherwise reasonably acceptable to the City.

5.4 Liens and Lien Waivers. The GranteeContractor shall take all action necessary to have any mechanic's and materialmen's liens, judgment liens or other liens or encumbrances filed against any real property contemplated by this Agreement released or transferred to bond within ten (10) days of the date the GranteeContractor receives notice of the filing of such liens or encumbrances. If any such lien or encumbrance is filed, the City shall not be required to make any Draws (as defined herein) until it is bonded over or removed and a copy of the recorded release thereof is received and accepted by the City. The City shall not be obligated to disburse any funds to GranteeContractor if, in the opinion of the City, any Draw, real property contemplated by this Agreement or any other collateral for the GrantProject Funds would be subject to a mechanic's or materialmen's lien or any other lien or encumbrance other than inchoate construction liens. 5.5 <u>Authority of City to Monitor Compliance</u>. During all periods of design and construction of the Project Scope, the <u>GrunteeContractor</u> shall permit the City's Chief Executive Officer or his/her designated personnel, to monitor compliance by the <u>GrunteeContractor</u> with the provisions of this Agreement and any Construction Documents. During the period of construction of the Project Scope and with prior notice to the <u>GrunteeContractor</u>, representatives of the City shall have the right of access to the <u>Gruntee'sContractor's</u> records and employees, as they relate to the Project Scope, during normal business hours.

5.6 <u>Construction and Operation Management</u>. Except as otherwise expressly provided herein, the <u>GranteeContractor</u> shall have discretion and control, free from interference, interruption or disturbance, in all matters relating to the management, development, redevelopment, construction and operation of the Project Scope, provided that the same shall, in any event, conform to and comply with the terms and conditions set forth in this Agreement, the Construction Documents, and all applicable and governing federal, state and local laws, rules, regulations and policies (including without limitation, applicable zoning, subdivision, building

and fire codes). The Grantee's <u>Contractor's</u> discretion, control and authority with respect thereto shall include, without limitation, the following matters:

(a) the construction and design of the Project Scope, subject to the express terms and conditions of this Agreement;

(b) the selection, approval, hiring and discharge of engineers, architects, contractors, subcontractors, professionals and other third parties (collectively, the "Vendors") on such terms and conditions as the GranteeContractor deems appropriate; provided however, that to the extent that the City furnishes to GranteeContractor the names and identities of Jacksonville-based vendors, including, without limitation, Jacksonville-based minority vendors, and to the extent that the GranteeContractor has the need to enter into contracts with vendors outside of persons employed by GranteeContractor or companies affiliated with or controlled by the GranteeContractor, then the GranteeContractor agrees to include all such Jacksonville-based vendors in the project Scope;

(c) the negotiation and execution of contracts, agreements, and other documents with third parties, in form and substance satisfactory to GranteeContractor; and

(d) the preparation of such budgets, cost estimates, financial projections, statements, information and reports as GranteeContractor deems appropriate.

ARTICLE VI Draws

6.1 <u>Maximum Amount</u>. Provided that the <u>GranteeContractor</u> has performed all obligations of the <u>GranteeContractor</u> then due and subject to compliance by the <u>GranteeContractor</u> with the terms and conditions of this Agreement, the City shall make Draws (each, a "*Draw*" and collectively, the "*Draws*") to <u>GranteeContractor</u> for the Project Scope, up to the maximum amount of the <u>GrantProject Funds</u> in accordance with the <u>Eligible Grant</u> <u>Expenditures and</u> Approved Draw Schedule attached hereto as <u>Exhibit G-1</u>. Prior to Draw, the <u>GranteeContractor</u> must hold a current occupational license to do business in the City of Jacksonville. However, in no event shall the City be obligated to make Draws of the <u>GrantProject Funds</u> in excess of 50% of the costs to perform the verified Project Scope cost, or the aggregate direct construction costs actually incurred and paid by the <u>GranteeContractor</u> in connection with the construction of the Project Scope in accordance with the terms of this Agreement.

6.3 <u>Draw Procedures</u>. All Draws shall be made from time to time upon written application of the <u>GranteeContractor</u> pursuant to a Draw Request. The <u>GranteeContractor</u> shall submit Draw Requests to the City in accordance with the Approved Draw Schedule attached hereto as <u>Exhibit G-1</u>, covering work performed since the prior Draw Request. Each Draw Request shall constitute a representation and warranty by the <u>GranteeContractor</u> to the City that (a) the work performed and the materials supplied as of the date thereof are in accordance with



9. Where is the 14-point analysis as required by 656.1206(e) done by the BID? Are all requests for tree removal granted no matter what?

10. The penalties for unpermitted removal of trees do not match the loss of the tree in some cases, such as the unpermitted removal of a 36" Laurel Oak, which would have a very large canopy is currently only required to be replaced with six 4" Laurel Oaks.

 Suggest aligning penalty for unauthorized tree removal with the loss of value of the tree as appraised by a professional arborist with that skill-set, and as determined by a hearing officer.

11. The penalty for over-pruning trees should not be as great as the penalty for totally removing the tree. This violation should be sent to a hearing officer who could hear from professional arborist that would recommend either:

 removing the tree and paying for its value along with other costs such as consulting fee, the cost of removal, and a fine; or

 set up a plan to rehabilitate the tree through some time period of growth and pruning, with an inspection at the end of the period.

12. Damage to the root system within the drip line should be specifically mentioned as a form of unauthorized pruning or damage.

a. The use of the term "drip line" does not adequately encompass the root zone of a tree. Suggest changing area protected to "root zone".

13. Barricades need to be at the root zone, and enforcement needs to happen.

14. A standard for barricades is 1.5 feet in diameter for each inch of dbh.

- a. So, a 10" tree would have at least a 15' diameter root zone barricade built around the tree, with the tree in the center.
- b. Suggest requiring the root zone protection and the area required to plant trees be revised to cubic feet rather than square feet. The depth to which new soil should be provided is 18", so 1.5' X the area required.

15. Create joint and several liability for Violator. Do not limit liability to property owner.

16. Define "person" if not already in general definition in Code.

17. Is \$50,000 the right amount today for clearing an acre without a permit? What if the acre was covered with large live oaks or long leaf pines?

18. In an initial phone conference with Chris McCormick of GIC, most codes reference the ISA standards for tree pruning, and consider it a violation of the code if those recommendations are not followed.

a. Check ISA to make sure it meets our needs.

 Suggest looking at other codes to determine a standard for penalties and how enforcement is accomplished.


