 - i. Ms. Powell- a lot of data but no analysis is a problem the city faces. Additionally, would like to see goal setting as an aspect of tree planning.
 - ii. Ms. McGovern- doesn't see why there is a rush to spend all the money if trees are actively being planted. Ms. Powell responded with potential legal issues of not spending more money and that trees are constantly being taken down.
 - iii. Mr. Souder- Jacksonville does a good job regarding the right tree for the right place.
 - iv. Ms. Fraser- there needs to be a look at the efficiency/effectiveness of our current tree planting programs.

- d. Mr. Colburn- What are Jacksonville's best and worst qualities?
 - i. Ms. Fraser- Jacksonville could do better in equity.
 - ii. Mr. Souder- Florida has more property rights than some other states, and it's a balance.
 - iii. Ms. Fraser and Mr. Souder- Insurance is telling people to remove trees.
 - iv. Ms. Fraser- Lack of permitting or enforcement for tree removals is an issue in the city.
 - v. Mr. Pope- Uneven canopy and clear-cutting large properties is an ongoing issue. Additionally, while wetlands are preserved, uplands are not.
 - vi. Ms. Powell- We have funding but no plan.
 - 1. Mr. Pope-Politics are a hinderance, red tape.
 - 2. Ms. Powell- We need a champion.
 - 3. Mr. Pope- Limited staff is a hinderance.
 - 4. Ms. Powell- Parks are a major asset.
- e. Mr. Colburn- What are your impressions of a 20-year goal? What would you like to see?
 - i. Mr. Pope- Good regulations that are enforced.
 - ii. Ms. Powell- Walkability, shaded sidewalks that add to the quality of life.
 - 1. Mr. Colburn- Walkability is achievable.
 - iii. Mr. Pope- The core is denser with trees that people realize, we need to consider perspective.
 - iv. Ms. Powell- FDOT is absent from all of the planning.
- f. Ms. Fraser- What do we need to get a rough draft of scope of work done?
 - i. Mr. Colburn- We need a champion.

 - ii. Ms. Fraser- We need consensus, then decide how to get money.
