#### 5. Election of Chairperson of Tree Commission

**Issue:** Current Tree Commission Chair Curtis Hart stated that his term has ended but could remain in the position until the Council President appoints someone for the position and replaces him. Hart explained that he discussed the seat with C.P. Salem and was advised by Salem that Salem was not ready to replace Hart (leaving Hart in the seat at Commission)

**Motion:** to re-elect current Tree Commission Chair Curtis Hart to remain as Chair until the Council President appoints someone for Hart's position on Commission.

Moved by: Susan Fraser Second: Nina Sickler

#### Discussion:

Members discussed the requirements of the position for the Chair and the fact that the Commission had previously voted on Hart as Chair. **Hart**: stated if someone else would like to serve he had no problem.

Vote: Approved, unanimous.

#### 6. Vacant position on Tree Commission

**Issue:** Rhodes Robinson, appointed by the City Council, resigned from his position on the Tree Commission and with no nominations put forward, the seat remains a vacant seat on the Commission. The Chair asked General Counsel and the city Arborist to reach out to Ron Salem about an appointment.

# 7. (Agenda Item taken out of order): Financial Report for Ordinance Tree Fund, Charter Tree Fund, and BJP

Jose Regueiro - Accounting: noted that he had been asked previous to provide the current return rates on fund accounts. He noted that November 2022-2023 rates are 2.33% and this year they are at 2.61% (APR 3.13). He also briefed combined revenue for January YTD compared to January 2023 was down 3.3M. January 2024 YTD 2.4million, spent. Revenues are down. The Charter portion of the Tree Fund is completely unused. Also, total unallocated funds increased by \$8.8 million.

[Near end of the meeting, as scheduled on agenda:] Justin Gearhart - City Arborist: in the three Tree Fund-type accounts (Charter, Ordinance, BJP) collectively is nearly \$22million.

There were no questions; no motion.

#### 8. Tree Commission Presentation

**Issue:** It has been a goal for the Tree Commission to present an overview to the City Council. This would define what the Commission does and can do within each Council member's districts. The City Arborist had been assigned this task in November 2023. City Arborist Justin Gearhart presented each slide and Commission offered edits to include the addition of particular charts, Level 2 and 3 explanation, current projects, and handouts.

**Susan Grandin** General Counsel: stated she would work on a plan to schedule which council meetings needed to be attended.

Justin Gearhart asked for a vote for approval prior to the corrections of the presentation being done because if the Commission waited it would be another month before the City Council could be briefed.

Motion: for Justin Gearhart to make the discussed edits to the presentation, and to distribute the final to each member to approve prior to presentation to the City Council.

Moved by: Susan Fraser Second: Nina Sickler

Discussion: none

# Vote: Approved, unanimous 9. Tree Fund Appropriation Request

Justin Gearhart - City Arborist: pointed out the timeline of certain Level 3 projects, including the fact of the reworking of Level 3 guidelines, which the Commission should expect for an increase in use of Tree Fund funds. Fund Status of 630-CITY, Remove and Replace (\$3m used), and Level 2 Programs (\$5m used): Justin Gearhart briefed that 22M was the current amount. Asked that the entirety of the Better Jacksonville Plan set aside for Tree Planting be appropriated to Remove and Replace.

Justin Gearhart - City Arborist presented the following proposed appropriations:

**2.5 million** from the Ordinance Tree Fund to be moved into Remove and Replace [previous appropriation to current request: \$1.2 to \$5.4]

**2 million** from the Charter Fund moved to Remove and Replace, which would allow live oaks and particular species of trees to be planted through that program. [previous appropriation to current request: \$0 to \$2m]

**3 million** from Charter Fund to Level 2 [previous appropriation to current request: \$0 to \$3m]

**6 million** from Ordinance into Level 3 for upcoming projects [previous appropriation to current request: \$1.5m to \$7.5m]

These requests would leave the Ordinance Fund at 2.1m; and the Charter Fund 4.2m and the BJP to \$0.

#### Highlights of the ensuing discussion include:

Justin Gearhart - City Arborist: offered the prepared material for the meeting details how each project under Remove and Replace is tracked, including Parks, Right-of-way, and how the program intersects with the general Removal program (general fund).

Susan Fraser: in light of the expected Management Plan, should the appropriations be for 1 year instead of 2.

**C.M. Miller:** noted that the function of the Tree Commission is to vet the planning projects and those decisions should rest

with the Commission. Miller emphasized that the Management Plan will likely serve as a guide for future projects, at present all the current potential projects should be vetted by the Commission with a view of the overall mission of improving the City. Miller noted that he did not yet fully understand the rationale for the specific numbers within the appropriations request but that the Commission, with their overall mission view, should be the ones to decide the amounts to request for appropriation.

Justin Gearhart - City Arborist: advised that the numbers were from looking at the spending from last year and making the amount cover a two-year period of the same. Gearhart noted that using Charter Funds was going to be first time.

**Chair Hart:** noted that Charter Fund money limits by specification which species of trees can be used for planning and requires more documentation.

Susan Grandin General Counsel: Grandin noted that the Tree Fund money can be spend on planting, as part of planting is the removal of obstructions which may include removing a dead tree, the percentages of use of the funds on remove versus the replacement planning should be appropriate.

The Commission generally discussed and concluded that the request appropriation amount was 2 years of funding and agreed that 1 year of funding should be moved rather than 2 years.

**Chair Hart:** asked why should 6 million go to Level 3 when nothing has been spent.

Justin Gearhart - City Arborist: explained that the Level 3 program had been reworked so it was easier to understand to request project funding so there will be more projects in the future.

The Commission generally discussed that the RiversEdge project was a unique situation and noted that the project will be presenting their request in the next commission meeting.

Nina Sickler: suggested that Level 3 should be funded generally, recognizing that Tree Commission is the entity to assess and vet planting projects not City Council. Tree Commission is the body of experts designed to vet major projects. **Susan Fraser:** questioned if appropriation of funds for Level 3 should not happen until there is a project and then goes to the City Council for approval.

**Dave McDaniel:** McDaniel and noted that Council had previously expressed that Tree Commission should not be coming to Council repeatedly.

Susan Grandin General Counsel: reminded the Commission that they are the "body of experts", and Council recognizes that. Grandin suggested that the funding amount for Level 3 should not be considered RiversEdge project as that is unique and must pass through MBRC per Level 3 protocol.

#### Motion:

\$1M from Charter to Remove and Replace; \$1.7M from BJP to Remove and Replace; \$1.5M from Charter to Level 2; \$6M from Ordinance to Level 3.

Moved by: Susan Fraser Second: Nina Sickler

Discussion: none further.

Vote: Approved, unanimous

#### 10. Potential Trees to Add to Approved Species List

Justin Gearhart - City Arborist: gave a presentation of new species of trees to be added based on the Mayor's directive. The Commission discussed the various fruit trees that have not worked in the past, maintenance, and irrigation systems that would be needed. [List can be found at Jacksonville.gov-Tree Commission, January 17, 2024 Meeting]

Generally: The Commission stated would be a good idea for some of the fruit trees to be planted at community centers so they could care for them. The Commission members emphasized that fruit trees take a lot of maintenance and will the support be available. Also noted is the increased requirement of irrigation for fruit trees; stated that the Parks and Recreation Division should be part of this discussion because of the operation cost. Jonathan Colburn - Urban Forestry Manager: reminded that "right tree, right place" is the guiding principle. **Motion:** To approve new species of trees to be added to the planning list based on the Mayor's directive - with conditions that Parks need to be in discussion to see if they desire a program with fruit trees.

Moved by: Susan Fraser Second: Nina Sickler

**Competing Motion:** To table the discussion until consult with Parks.

Moved by: William Burk Second: Nina Sickler

Vote on competing motion: none; issue tabled by Chair.

Jose Regueiro - Accounting: Briefed February 2024 Financial Highlights [Financial Highlights can be found at Jacksonville.gov - Tree Commission, March 20, 2024 Meeting]

There were no questions, no motion.

#### 2. Prior Meeting Minutes

Issue: approval of prior meeting(s) minutes: February 21, 2024 (requires motion & vote), January 17, 2024 (prior motion, but not vote).

Motion: to "defer" issue of January and February meetings minutes [in substance, a *motion to postpone to certain time*] to next meeting, to allow correction of Scrivener's errors in February Minutes and to provide copy of January minutes at next meeting.

Moved by: Nina Sickler Second: Curtis Hart

**Vote:** approve, unanimous

#### 3. RiversEdge Level 3 Project

**Issue:** The District Community Development District requested additional funding from the Tree Commission to plant over 400 trees with additional soil volume improvement strategies that include structural soils and Silva Cells. RiversEdge is projected to be a riverfront destination with public spaces owned by the City of Jacksonville, to include parks, Riverwalk, multi-use paths, and streetscape.

#### Highlights of the ensuing discussion include:

Mike Mullis - District Community Development: distributed packets explaining the cost and options with the requested amount of funding needed for each [available at <u>Jacksonville.gov</u> - <u>Tree Commission</u>, March 20, 2024 Meeting] The initial proposed request is for \$998,000. Lori Boyer - COJ Downtown Investment Authority: explained role of DIA and the Parks department because it is a hybrid application.

- There are currently City owned parks and certain roads that provide access to the parks developed by a developer on request using city dollars. The tax increment is funding the construction and improvements in those parks and funding the construction of those roads, this would typically be Type 2.
- City has contract with the developer for them to execute on the city's behalf it is in the application as a Type 3.
- Difference between CRA roads and parks and CDD roads. CDD roads a developer develops roads and dedicate to the public. CRA roads and parks designed, and all improvements approved by city.
- COJ Downtown Investment Authority has been involved, reviewed the plans, approves the elements that are permitted within the parks. The CRA roads and park spaces are public improvements on public spaces.

Mullis: stated that they have been working with the parks since 2019 and been involved with the four parks development. Confirmed that all roads and roadways will maintain areas indefinitely by the CDD. A physical model was utilized to explain the layout of the approximately 30-acre plan.

Hannah Mircale - District Community Development: briefed the base bid budget, each option, and additional add-ons (as depicted on a chart in the distributed packet).

**Boyer:** stated on the CRA roads and CRA parks: \$23M as well as \$4M on the current overage.

Mullins: clarified that for hardscape, landscape, irrigation, and associate (park benches, etc.) are currently bid at approximately \$17million.

**Boyer:** explained that \$23 million is a fixed budget for the parks as a whole (separate from roads) and that amount includes, for example, a slide for the playground. So, without Tree Fund funds, the required trees would be paid for instead of a slide in the playground (as the budget is fixed). Further, Boyer reiterated that without Tree Fund funds other amenities must be cut, or less trees and less amenities. As to CDD roads, the developer has an obligation to plant a minimum threshold of

trees. Such is the reason for separating the CRA ask from the CDD ask.

Members concluded that they are being asked to decide to what extent, if any, they wish to authorize funding to support the DIA plan for the included City Parks elevated tree canopy (including instead of shade sails), through the additional funds specific for trees (allowing other funds to be used for elevated amenities). As well, to what extent City wants to elevate the planting of trees on the right of ways. Fraser: clarified that Tree Fund funding is to support DIA vision for the City owned portions of the project designed to emulate a suburban streetscape in an urban context (an augmented design).

Hart: suggested using an approach based on a particular park ("pick a park") and focus on the particular park with enhancements aided by the Tree Fund funding, i.e., use Silva Cells in a particular park.

**Boyer:** clarified that the base bid, \$998,000 is to place trees in the parks, but that the Commission needs to decide if they wish to fund a pilot program for enhanced soils and/or Silva Cells, and to prioritize what the Commission wants to have included in the project for Tree Fund funds.

Hannah Mircale: that Bid Alternative 9 included the enhanced soils, cost share for irrigation and upsizing to 6-inch trees, with Central Park trees at 8-inch trees.

**Fraser:** raised the question of the use of larger caliper trees planted.

**Members** discussed and agreed that they would require 4-inch trees (instead of 6-inch) because of adaptability and cost saving. The Commission also asked and received the approximate cost per tree, structural soil, and Silva Cells and for an amended request specifying the funding parks. The Commission concluded that they are committed to fund walk, the trail and the parks, and "test locations" for the use of Silva Cells and the use of enhanced soils with Tree Fund funds.

Motion: to fund the RiverEdge Project at \$1,212,000, which includes base condition (\$998,000) for trees for parks, plus Silva Cells on park side of RiversEdge, structural soil on the opposite/south side of road; conditioned upon the build of Alternate 2 and maintenance of Crepe Myrtles in approved method.

Moved by: William Burke

#### Second: Nina Sickler

Discussion: none further.

**Vote:** Approved, unanimous.

<u>Of note</u>: Members discussed that future large planning projects should include Tree Commission participation early in the project.

#### 4. Fund Status

Justin Gearhart: solicited questions on the fund status. (none)

#### 5. Level 2 Project Update

Justin Gearhart: briefed Twin Lakes project was off warranty, Sheffield Park was installed, and District 7 & 10, and Hodges Blvd were complete. There were no questions, no motion.

#### 6. New Business

Susan Grandin: Informed everyone the Urban Forest Planning Committee would meet in two weeks if anyone would like to attend. Stated that Council President Salem sponsored \$300,000 and another \$200,000 currently coming from the Resilience CIP fund. Grandin explained that the impending Urban Forestry Management Plan includes more than resiliency and the Resiliency is \$10million /year for 5 years (leaving approximately \$27million). Grandin pointed out that planting trees is "green infrastructure."

# 5. (Agenda Item taken out of order): Financial Report for Ordinance Tree Fund, Charter Tree Fund, and BJP

Jose Regueiro - Accounting: Briefed March 20, 2024 Financial Highlights (Highlights can be found <u>Jacksonville.gov-Tree Commission</u> April 17, 2024 Meeting, stated Commission has \$23.1M to appropriate to projects. Currently do not have a solution for the \$1.7M Better Jacksonville Plan which is part of the \$23.1M.

General discussion about the overall strategy of spending funds through the Tree Commission. Discussion of ebb and flow of funds coming in. Reiteration of the role of Tree Commission to strategically consider planting projects and expectations of projects proposed, in scope and in stage of project.

#### 6. Proposed Level 2 Program Projects

#### A. Ribault Scenic Drive Park Project, Proposed

**Issue:** Tree Planting by St. John's Riverkeeper for right of way buffer, shade for parking lot, walkways, and scenic seating areas. Trees will be installed to coordinate with the existing irrigation system.

Jimmy Orth - St. Johns Riverkeeper: briefed proposal being a part of a program started a year ago Resilient Ribault partnering with LISC Jacksonville. Benefits include: Improving water quality, assist in flood prevention, enhance access to water ways and approve parks, and housing security. Kathleen Parks - Development Coordinator: requested \$21,675 for funding.

#### B. EdgeWood Park Project, Proposed

**Issue:** Residents proposed tree plantings to complement existing features and provide right of way buffer. Walkways and benches will be shaded. Residents actively monitor the area and would do the same for the proposal.

McGovern: briefed plan and explained how involved the Residents are in the area and it would be under warranty for a year. Fraser: added asked about the random cabbage palm in the plan and it was explained one Resident would like to have one.

#### C. Pine Trailhead Project, Proposed

**Issue:** Starting point for new trail system off the Gold Star Parkway in the Thomas Creek Preserve. Planting was coordinated with St. Johns River Management. Priority to keep the horse trailer and parking space open and accessible while providing shade.

**McGovern:** briefed plan and explained the details of the area. Large turn around area and wanted to provide shade as well as barrier so cars do not destroy area.

**Fraser**: asked if people park where they want and wants to ensure that people don't park on or around tree planted area, suggested raised area.

#### D. Sal Taylor Creek Preserve Project, Proposed

**Issue:** Coordinated with COJ Preserve to plant trees in grassy parking lot area to keep horse trailer and parking space open and accessible while providing shade. The recreational area will receive a few shade trees and Cedars will provide a buffer for the picnic tables and pavilion. **McGovern:** briefed proposal and explained details of area. Busy area but very dry with little shade. Explained there is water to the site. **Fraser:** expressed same concern as with Pine Trailhead with barrier needed to protect trees.

#### E. Northwest Legends School Project, Proposed

**Issue:** Coordinated with DCPS Real Estate and Maintenance. Plant trees in grassy areas adjacent to the recreational fields and tracks. All planting and watering are coordinated with DCPC.

**McGovern:** briefed proposal and explained details of project, would be out of the maintenance area and activity area.

#### F. Winton Dr. Park Project, Proposed

**Issue:** Old landfill site proposed to become loop trail with parking once old debris and drainage improvements.

**McGovern:** briefed the proposal with details of the project, told it would be 6 months for the construction to be complete and would be tasked to parks.

William Burke - Commission Member: raised question of soil remediation, if they were removing and replacing soil.

**Hart:** Suggested to table proposal; regarding remediation and potential additional costs.

Motion: As to the proposed Level 2 projects proposed -Approve, <u>Ribault</u> - \$21,675 as presented Approve, <u>Edgewood Park #1</u> - \$14,500 as presented Approve with conditions, <u>Pine Trailhead</u> - \$28,325 with conditions to have raised barrier or structure for parking to prevent planted trees from being runover or parked against. Approve with conditions, <u>Sal Taylor Creek Preserve</u> -\$44,200 with conditions to have raised barrier or structure for parking to prevent planted trees from being runover or parked against. Approve, <u>Northwest Legends School</u> - 28,100 as presented Table for additional information, <u>Winton Drive Park</u>. -

Moved by: Susan Fraser Second: William Burke

**Discussion:** none. Commission would like a post-planting report. **Vote:** Motion as stated approved, unanimous.

#### 7. Status of legislation to move funds to Remove/Replace

**MacGillis**: stated the appropriation bill is in draft, that included some pre-draft from Susan Grandin. Informed Commission that she will still need additional meeting with Public Works to go over numbers. The due date will be 2:30, May 8, to go regular cycle, with backup of May 28, as 1-cycle to stay on course for June 11.

**Chris Miller - Council Liaison:** Reconfirmed that the numbers are justified based on intent of the Committee and previous and future funding.

Fraser: raised the issue to reopen discussion on Level 3 funding needed to be adjusted from the original 6 million request. Sickler: Requested that Public Works and Parks get an opportunity before the legislation goes in to put together a potential Level 3's to put that into the justification. Justin Gearhart - City Arborist - pointed out the difference between Level 2 (City Project) and Level 3 (Developer, nonprofit, and there is currently \$4.2M in Level 2 not committed. John November - Public Trust: regarding purpose of pervious lawsuit; expressed approval of the Level 1, 2, & 3 programs. Stated that there will be more Level 3 coming and recommended not cut back the 6-million request for Level 3. Fraser: questioned if having the funds appropriated may add pressure on Commission. MacGillis: suggested that appropriations should be based on the strategic view of the Commission; a reasonable basis for belief of smart allocation of funding for potential future projects. Hart: stated he thinks that \$6M Level 3 is too much and should be \$500,000 and if projects come up can go back to the Council. Sickler: suggested cut the \$6m by half to \$3million. Miller: suggested that fund with a buffer above what you

anticipate.

Justin Gearhart - City Arborist - cautioned that Level 3 had to be shut down to rework the process, so there is not a pure spending history. Asserted Level 3 justification for 1.5million, or more, appropriation to Level 3.

Motion: amend \$6M fund move to Level 3 to \$2M, \$1.5M with 33% for buffer.

Moved by: Nina Sickler Second by: William Burke

**Discussion: Hart:** asserted the number should be based on certain projects; **Sickler:** the 1.5 million is based on history with 33% buffer; **Fraser:** inquired about fiscal year limitations and

suggested to keep the amount small then go back and request in October when we have the projects; Burke: asked about roll-over; Commission advised that the funds do roll over); Miller: stated that keep in mind when Council members learn about what the Tree Commission can do, there will be more requests. Also, suggested projects be presented at the earliest stages to have Tree Commission be part of the process of the project, not after the fact (late in a project). Hart: pointed out that a recent project proposal was not pressure on the Commission, but more disappointment in the timing the developer presented the project. Asserted that the \$21 million is not for planting trees anywhere, there is the process. Agreed to the \$2million as stated in the motion. Jonathan Colburn - Urban Forestry Manager - raised the fact of Urban Forestry Management Plan.

**Vote:** Approved, unanimous.

#### 8. Tree Commission Presentation

**Issue:** Need to get dates to go in front of the Council. Currently only have been in front of Neighborhoods.

Hart: Need to shorten and format the presentation.
MacGillis: stated she would get with chair with a possible
schedule.

Jonathan Coburn - Urban Forestry Manager: briefed come up with strategy for planting, minimum planting wells ordinances were minimal. Asserted that having Tree Commission be part of early stages of planning projects as the process recommended in the Urban Forestry Management Plan. Hart: asserted that any project funded by Tree Commission must plant in the manner proscribed by the Commission. Requested the Coburn produce planting standards for consideration and potential task force/subcommittee.





- Combined revenues YTD are \$3.4 million compared to \$2.9 million for Aprr-23, an increase of \$505k.
- Combined expenses YTD are \$3.5 million compared to \$2.3 million for Apr-23, an increase of \$1.2 million.
- Combined revenues for Apr-24 were \$551k, and expenses were \$404k, leaving the funds in a favorable revenue position for the month.
- Unappropriated/Unallocated (including BJP funds) were \$23.0 million, compared to \$14.3 million for Apr-23.
- The Ordinance fund (15304) YTD has expenses exceeding revenues by \$650k. For Apr-24, revenues exceeded expenses by \$32k.

Howell was advised by **Hart** and **Shannon MacGillis** that he could participate in the discussion but was not allowed to vote until the final approval vote from the City Council.

# 5. Prior Meeting Minutes.

**Issue:** The minutes for the meetings of February 21, March 20, and April 17, 2024 pending approval.

Susan Fraser - Commission Member: stated the February minutes on the issue of Trees to Add to Approved Species List, were not specific enough and needed to be amended to reflect the specific conditions that Parks would need to present a presentation before fruit trees are used to show they have a plan how to manage them in public places.

Motion: to amend minutes of February 21, on page 7, regarding the motion on Fruit Trees, to reflect the specific condition that Parks "make a presentation regarding fruit trees".

### 6. June Meeting Date

Issue: The third Wednesday in June fall on a holiday

General discussion about moving meeting from June 15 which is a holiday. Sickler suggested that we circulate emails. MacGillis stated that dates could be discussed by "one-way" emails but not emails to "all" or between multiple Commission members, to prevent Sunshine violations. Hart: Staff assigned to get some dates to the members for scheduling.

Hart raised the point to Howell, and other members possibly, needing to attend the Ethics/Sunshine Course. MacGillis stated that she would check on the next offerings and for those seeking attendance to email her.

## 7. Design Standards Subcommittee Discussion

**Issue:** Further discussion on Design Standards that was touched on in the last meeting that included tree planting, the medium, and what trees were planted in.

**Burke:** Stated that he had done designs for the city in the past and Public Works has some standards. He explained that this information could be used.

Hart: Explained that Context Sensitive Streets Special Committee (CSSSC) deals with everything above the ground but feels they do not take in consideration below the ground. Dave McDaniels: stated the Subdivision Standards and Policy Advisory Committee (SSPAC) was working on the manual rewrite. Hart: advised William Burke to attend the next SSPAC and report back to the Commission.

Generally: The Committee discussed the benefit to the Tree Commission of Tree Commission having a set standard so that applicants for use of Tree Commission funding could be implemented during the development phase of planning and going to other committees and getting more information from the Urban Forestry Manager will assist in the task.

Hart: deferred the discussion to the next meeting.

# 8. Level 2 Project Proposal Alden Road

**Issue:** Tree Planting project proposed in the northern Right of Way of Alden Road between John Promenade Blvd and Alden Trace Blvd W. The project would consist of planting a variety of shade trees that would serve as an aesthetic improvement and heat reduction. The planting would also help filter and slow down stormwater runoff.

Justin Gearhart - City Arborist: Briefed project and exact location for the plantings. He explained the area has dry soil, so the species selected was based on this. Justin stated that it would be a combination of 12 Sycamores, 18 Pine, 7 Yaupon Holly, and 4 oaks. He also explained that it was clear of the water pipes and that it has been cleared by Traffic. The trees will have a two-year warranty. Requesting \$76,282.56. Fraser: Stated Sycamores can be problematic with their leaves and would recommend live oaks.

**Gearhart:** Explained that the use of Sycamores add diversity due to the amount of oaks already in the area, and Sycamores do well in the soil, and grow fast for the canopy, and may help keep certain disease (rust and canker) down, and having Sycamore being a part of the planting project adds color and quick shade, therefore meet the needs of the consumers of the area being planted.

Generally: The Commission discussed whether Sycamores or Oaks should be used. This also included the spacing of trees, distance from the sidewalk, and distance from water lines.

Motion: to approve Alden Road, as presented.

Motion by: Nina Sickler Second: John Moscarillo Vote: approved, unanimous.

9. Financial Report: Jose Regueiro not present. Chair Hart: deferred to next meeting.

# 10. Fund Status of 630-City, Remove & Replace, and Level 2 Programs

Justin Gearhart - Briefed as of May 1, 2024, remove & replace was \$429,985 but will come down to about \$200,000 due to various projects, 630-CITY \$2,371,402, Level 2 down \$1M and is now \$3,491,079, Level 3 \$1,549,250 but Level 3 projects have not been paid (RiversEdge and Mayport). Total funds not obligated \$2.7M.

Fraser: asked for BJP funds update.

**MacGillis:** Draft will be filed May 22 - \$1M Charter to Remove and Replace, \$1.7M BJP to Remove and Replace, \$1.5 Charter to Level 2, \$2M Ordinance to Level 3. Through the bill, all the BJP funds will have been moved. Introduction to Council May 28, Committee week June 17, and final Council action June 25.

## 11. Level 2 Updates

**Gearhart:** Briefed Baker Front, Gold Star Phase 1, Kernen Blvd, and Ft. Caroline have reached the end of warranty period. **Hart:** asked to have completed list in the meeting.

## 12. Status of Level 2

**Gearhart:** briefed not a lot of changes from month prior, currently in the last month of Gold Star. Several projects will be out of warranty.

## 13. Parks Department Project Update 🧄

**Kathleen McGovern:** Riverwalk Phase 2 is in progress, S-line is 30% complete and Lift Every Voice and Sing parks is in progress. Community centers are getting started.

## 14. Public Comment - out of order

Nancy Powell - Scenicjax Stated River Front plaza was started the tree plan didn't come through the Commission and number of trees were taken down. Stated she and others had asked to design around the large, older trees. Other parks are coming and will ask for money need to take this into consideration. Sickler: stated that she will ensure this happens, but it will only come in front of the Tree Commission if they request funding.

Generally: Committee discussed the scope of the Tree Commission. Does the project have to come through the Commission if they are not asking for money as part of the tree preservation and what authority the Commission has. The Tree Commission, by ordinance, has the scope of monitoring all planting projects and the Commission needs to get guidance from administration as to the full role intended for the Commission. **Hart:** Stated that it is up to the administration to set the role beyond overseeing the money; and agreed that the authority to review non-Tree Fund requests is within the ordinance scope of duties of the Commission.

Sickler: Stated that she can have the Project Managers build it into their schedules to present their project before the Tree Commission for information and input and it would add value. Hart: Stated if this happened then this could be the public forum for the CIP projects. **Sickler:** suggested that City could present a CIP funded project to the Commission and the Commission could make additional planting suggestions or modifications to the plan with the additions being funded by Tree Fund.

Hart: agreed that City could present a CIP funded project to the Commission and the Commission could make additional planting suggestions or modifications to the plan with the additions being funded by Tree Fund. Hart suggested that an ordinance could read of a 10% threshold of tree removal must come to Tree Commission.

**MacGillis:** pointed out that the current ordinance articulates that the Commission has the authority to review historical trees and exceptional specimen trees.

Hart: stated he could set up Subcommittee, including himself and Fraser and anyone else, to create criteria regarding tree size requiring pre-application that mandates the project come through Tree Commission to come up with criteria for whether trees come down or not and get an ordinance created for the Council to approve.

**MacGillis:** asked if this was intended as a running Subcommittee or a Task Force; **Hart:** his intention is to set up a Task Force to consider processes to cause any project with historic or exceptional specimen trees come to Commission, pre-permit.

# 16. New Business

Jacksonville City Council 2024 leadership Installation Chair explained event to occur on June 20 at 5pm.

**Fraser:** asked if the group "Late Bloomers" could present at a future Commission meeting. (**Hart** stated to put it on an agenda)
