#### **ELIGIBILITY**

- · Nominees must be residents of Jacksonville-Duval County.
- · Nominees must be sixty (60) years of age or older.
- · Nominee has made an impact in the community and/or for older adults during the 2023 for the male and female of the year.
- · Lifetime nominee has exemplified good work in the community and/or for older adults throughout their lifetime.
- · Nominees must not work as full-time paid employees of an organization or business whose primary purpose is to serve the older adult population.

#### **CRITERIA**

- The nomination must reflect the actual accomplishments(s) achieved <u>during the past 2023</u> <u>year for male and female of the year</u>.
- The nomination must reflect the actual accomplishments(s) achieved <u>throughout their lifetime</u> for the Lifetime Achievement recipient.
- · Current members of the Jacksonville-Duval County on Elder Affairs are not eligible.

- Complete the nomination form online or on the reverse side of this sheet. Attach a supporting statement of no more than 800 words describing the nominee's activities, achievement(s), and accolades. You may also include appropriate support materials. **Do Not** submit video tapes, displays, films, or scrapbooks.

- · All entries should be received by our office no later than August 14, 2024.
