## **Meeting Summary**

1. Welcome and Staff Introductions – This is a training session for the Board, agenda items are for discussion purposes and may be agreed upon by consensus. All future meetings of the Mayor's African American Advisory Board (MAAAB) must be properly noticed to the public seven (7) working days prior to the meeting.

On behalf of Mayor Deegan, **Dr. Parvez Ahmed** thanked each Board Member, who are busy professionals already doing great things in the community, for giving of their time to help this administration do what is necessary to be effective as an administration.

Dr. Ahmed thanked Neighborhoods Director Waters for his support of the MAAAB.

# 2. Dr. Ahmed stated that Executive Order 2024-02,

https://www.jacksonville.gov/ogc/docs/executive-orders/2024-02-mayors-african-american-advisory-board which created this Board, details the purpose of the Board and how you are to conduct the people's business. He emphasized that this is your Board, and our job is to be supportive in terms of carrying your messages to the Mayor or to members of City Council, if there are policy initiatives or community concerns you wish the Mayor or the Council to be aware of and/or address.

## Section 5 of the Executive Order addresses the functions of the Board.

"The Board shall act as a liaison between the African American community and City government. The Board shall report to the Mayor and the City Council, at any time it deems necessary, any findings and/or recommendations It desires to make. At a minimum, the Board shall prepare an annual Report consisting of findings and recommendations to the Mayor and

City Council. This annual report shall be submitted no more than thirty (30) Days after the close of the preceding calendar year."

**Section 3 of the Executive Order** establishes the Board, sets forth staggered terms to be served and names the officers of the Board.

"The board shall consist of eleven (11) members. Each member shall be Appointed by and serve at the pleasure of the Mayor."

More than 100 applications were received and after a vetting process, the initial 11 persons were selected to serve on this Board. There are currently ten (10) members serving on the Board due to one member's resignation. That vacancy is in the process of being filled.

"The members of the Board shall serve for terms of four (4) years."

The Executive Order spells out the staggered terms, reappointments and the filling of vacancies.

## Officers of the Board:

"The Board shall annually elect one of its members to serve in each of the offices of Chair, Vice Chair and Secretary."

Dr. Ahmed noted that the City of Jacksonville has various opportunities to serve on other Boards and Commissions. For a list of Advisory Boards and Commissions: go to Jacksonville.gov - Boards and Commissions.

As the MAAAB develops program and policy ideas, Dr. Ahmed requests that the Board keeps in mind that they serve at the pleasure of the Mayor and that they should be consistent with the Mayor's priorities, which can be found on her home page <u>Jacksonville.gov - Mayor</u> and he encourages the Board to become familiar with the priorities.

# The List of Mayoral Priorities are:

- Arts, Culture, and Entertainment
- The Economy
- Health
- Infrastructure
- Military and Veterans Affairs
- Public Safety

Dr. Ahmed also recommended that the Board acquaint themselves with the summaries of Mayor Deegan's Community Conversations, which were held this summer, to give the Board a good understanding of the types of issues and concerns raised by the community.

**Mr. Garrett Dennis** also expressed his thanks to the Board for serving. Boards and Commissions are important and are a way to influence policy. The Mayor wants City government to reflect Jacksonville. She is interested in diversifying every Board.

Mr. Dennis asked the Board to look within their respective networks and help identify individuals to serve on various Boards and Commissions, as well as, to identify individuals to replace Board Members as they transition on to other endeavors.

**Introductions** – Each board member and Staff introduced themselves. After the introductions, Mr. Ahmed returned to the formal business of the Board Training Session.

## Appointment of the Chair

Mr. Ahmed stated that the Mayor appoints the first MAAAB Chair. The Chair shall serve for one year. **Dr. Barbara Darby** was selected and did accept.
