Meeting Summary

- **1. Call to Order/Verify Quorum:** Chair Shumaker called the meeting to order at 5:31 pm. Edwina Henry verified that a quorum was present.
- **2. Approval of Previous Meeting Summary:** The CPAC Members approved the May 6, 2024, meeting summary.
- 3. Presenter: None.
- **4. Elected Officials Report:** The Honorable Warren Jones, School Board Member, Duval County Public Schools, gave the following updates:
 - The Duval County Public School Board voted to hire Dr. Christopher Bernier as the Superintendent. Contract negotiations are ongoing with Dr. Bernier, but he is expected to start work on July 1, 2024. He is a very competent and experienced superintendent.

- Dr. Dana Kriznar was acknowledged as having done an outstanding job and her hard work is appreciated. School Board Member Jones indicated that Dr. Kriznar is ready to retire.
- Regarding the list of potential school closures, School Board Member Jones indicated that
 no schools will be closed this year and that the Board will decide which schools to close or
 consolidate.
- Each Duval County School Board Member is having a community meeting in their district to discuss school closures. The closest meeting for the Urban Core CPAC Community would be June 10, 2024, 5:30 pm, at the School Board Administration Building.

JTA – Jeremy Norsworthy, Contract Specialist, provided information on the Transit Development Plan (TDP), which is a strategic plan which guides the development of public transit services over a 10-year period, ensuring alignment with community needs and regular and regulatory requirements.

- The TDP is essential for improving the transit system and for securing vital funding from the Florida Department of Transportation.
- Comprehensive public outreach is a component of the Transit Development Plan. JTA has
 developed a survey to collect public input from the community, in addition to holding and
 attending community meetings.
- Data gleaned from the survey and public feedback will help identify service gaps and opportunities for improvement. The feedback will help JTA tailor service recommendations to address specific needs of the community.
- All feedback will be shared with FDOT.

MCCD - Robert Bautochka, Code Compliance Supervisor, stated that currently the Municipal Code Compliance Division is down to only three supervisors, but plan to fill the three open supervisor positions by the end of the month. Chris Billings is now the Code Compliance Contracting Manager. The Urban Core CPAC will receive one of the new hires as your permanent MCCD Supervisor.

- In the last 30 days, Code Enforcement has completed 1,066 cases (9,889 since the start of the fiscal year) and removed 35 litter signs (610 since the start of the fiscal year).
- Mr. Bautochka reminded everyone to assess their property for dead and damaged trees to minimize the potential for storm damage, now that we are in hurricane season.
- Complaints may be called into 630-CITY or entered in the myjax app. As a reminder, every complaint needs a name and address. The city no longer accepts anonymous complaints.

- 9. Subcommittees and Liaison Reports:
 - Governmental Affairs Land Use and Zoning Subcommittee Dimitri Demopoulos, Chair. The Subcommittee reviewed three applications. No action was taken.
 - **Blight Subcommittee** Ernest Smith, Vice Chair the subcommittee met 5/16/2024, and discussed the status of several follow-up items.
 - Reverend Davis provided a report on a successful neighborhood clean-up in the Durkeeville Community.
 - The Jacksonville Housing Authority (JHA) did follow-up on a request for a list of vacant lots owned by JHA.
 - The subcommittee expressed concern for the reported blighted area of West 25th and Fairfax, near Grunthal Street. Subcommittee member Frazier will follow-up with Municipal Code Compliance.
 - Another area of concern is under the Park Street Bridge, over McCoy's Creek.
 - A homeless encampment was sighted at West Ashley Street, near Johnson Street.
 This is an I-95 overpass.
 - **Homelessness Subcommittee** Cory Haynes, Chair the subcommittee met 5/17/2024, and reported the following:
 - The subcommittee wants to continue referring people to local agencies for homelessness (services/resources).
 - The subcommittee wants to start compiling mental health resources.
 - The subcommittee would like to join forces with the Blight Subcommittee and hold a
 joint community event. Details to follow.
 - Taxation, Revenue Utilization of Expenditures (T.R.U.E.) Commission Kim Pryor, Representative gave a brief report:

- o In May, the Commission had a report from the Office of the Inspector General, who provided an overview of what the office does.
- o For the June 6, 2024, meeting, which will be held at 4 pm in the Don Davis Room of City Hall (meetings are open to the public), there will be two speakers. The first speaker will be a representative from the Associated Builders and Contractors to talk about the procurement code rewrite. The second speaker will be Anna Brochet, who will speak about indigent care contract monitoring.

- Ashley Cox, an attorney practicing in the Urban Core at the Bedell Law Firm on Adams Street, expressed her appreciation for all the work the CPAC is doing for the Urban Core.
- Marcia Ellison, from New Town Success Zone, inquired about the recent proliferation of ATMs throughout the neighborhood, and wanted to know where do they come from? Who's sponsoring them? And whose idea was it to place them in the neighborhood? Perhaps this is a question for Code Enforcement? They don't appear to be very secure and safety is an issue.
