# II. Presentation and Discussion – Viva Labs Sensors, Chad Jacobs

- Viva is a global safety technology company that provides insights into modal shift, road safety, congestion and equity
- The typical approach is reactive—to crashes or community reported near misses
- The issue is not really knowing what is going on the streets Viva wants to make data omnipresent, and provide real time data
- There are two sensors running in Jacksonville
- Viva sensors use AI neural networks, and can collect 10 different vehicle classes
- Near miss data is a measure of road user interaction
- Viva technology renders road users into 3D understand dimensions of road users, allows them to understand behaviors
- Each sensor costs approx. \$5,000. \$1,000 to install for each, \$600-700 per year per sensor to access data
  - Viva Software as a service company
- Data helps inform decisions about to how make safety improvements
- Mr. Jacobs provided a demo of the Viva near miss data it can be filtered by interaction pair, vehicle class, category (behavior)
- BPAC members asked Mr. Jacobs and Mr. Fall to share a one-pager of data from the Jacksonville sensors at Beach Blvd and St Johns Bluff

#### III. Discussion - Core 2 Coast Survey Update, Matt Fall, COJ Bike/Ped Coordinator

- Alignment study underway
- Benesch working on behalf of NFTPO as part of the UPWP
- Route will travel from the east side of Fuller Warren Bridge SUP to the Beaches
- Public Survey closes May 20, 2024
- Study completion by June 30, 2024
- Study will identify preferred alignment and general engineering feasibility
- Route will be mostly a shared use path along roadways

### IV. World Day of Remembrance 2024 Event Planning, Lauren Rushing

- Motion to officially pursue hosting the WDoR event in November 2024. Peter Borenstein tabled and Kelly Jones seconded the motion

# <u>V. Discussion – Feedback on Post Street - SR 228 at Old Roosevelt Blvd Intersection Improvement Project</u>

- Written comments are due by May 6, Lauren Rushing led discussion
- Add bicycle lane on Post Street from intersection west to Edgewood Avenue there is sufficient space, and bike lanes are proposed as part of COJ's 2017 Bike/Ped Master Plan (could show existing and planned network using map tool: <a href="https://coj-planning.maps.arcgis.com/apps/webappviewer/index.html?id=693bf590abdd451e9968b">https://coj-planning.maps.arcgis.com/apps/webappviewer/index.html?id=693bf590abdd451e9968b</a>
   13fa3b1952b)
- BPAC will send an official comment but members can send individual messages
- Add bike ramps leading onto shared use path particularly for east/west movements
- Add island or median to serve as a protected turn for bikes at the northwest corner of McDuff and Post Street - refer to Peter's markup
- Remove slip lane and right turn at the corner of Post and Old Roosevelt opportunity to repurpose into greenspace, plaza, or potential development site refer to Peter's markup
- Consider adding material on train tracks so bicycle wheels won't get stuck
- FDOT has a Bicycle Ramp 'Standard Detail' design
- Example: Bike Ramp on Lone Star Road near Tree Hill Preserve https://maps.app.goo.gl/PeBdPhbYYabUAtak9
- Consider opportunity for landscaping/beautification instead of just railroad ballast/gravel in the center
- The committee briefly discussed an updated COJ Complete Streets Policy that could be added as a future agenda item. BPAC could provide feedback - and potentially a form a subcommittee to discuss further.
