IV. Executive Director’s Report

Timothy Johnson provided the Advisory Committee with an update on proposed changes to the Board Rules. Previously, the language required the Advisory Committee to conduct a public hearing on all disability applications. However, if both the Medical Director and PFPF Staff recommend granting the disability pension, a hearing is unnecessary. This change ensures that hearings are only conducted when a denial is recommended.

James Holderfield explained that streamlining the Board Rules for disability pension applications would eliminate the need for the Advisory Committee to table applications while awaiting additional information from the employer.
