Summary

- Manager Update Workshop
 - a. JP Morgan

Katie Hammond, Jason Curran, Larry Ostow, and Olivia Schubert from the firm J.P. Morgan gave the following presentation on the Strategic Property Fund (SPF) for the Jacksonville Police and Fire Pension Fund. The presentation covered J.P. Morgan Asset Management's real estate platform, highlighting its \$68 billion in assets under management and a disciplined investment approach combining top-down research and bottom-up execution. The team provided an investment summary, reporting that the fund has seen three consecutive quarters of positive total returns and has outperformed its benchmark by 300 basis points. They discussed the U.S. real estate market outlook, noting improving conditions in the office sector, strong fundamentals in multifamily housing due to supply shortages, and the continued growth of industrial and retail assets. The SPF's strategic positioning was emphasized, including its focus on high-quality assets in growth markets, disciplined liquidity management, and targeted sector allocations to enhance returns. The presentation concluded with a review of the fund's balance sheet strength and future outlook, predicting a favorable investment environment driven by rebounding capital markets and stable real estate fundamentals.
