# Summary

- I. Manager Update Workshop
  - a. Pinnacle Associates

Andrew Eras and Richard Rosen outlined the investment strategy, team expertise, and portfolio performance of Pinnacle Associates:

The fund employs a bottom-up, fundamental approach with a focus on long-term growth and strategic market cap allocations. The investment team, consisting of experienced professionals, emphasizes stability and high active share in stock selection. Portfolio construction targets U.S. stocks with market caps between \$100 million and \$3 billion, maintaining diversification and strict risk controls. Performance has faced challenges due to macroeconomic factors, including rising interest rates and sector-specific downturns, but the fund anticipates recovery through catalysts such as industrial sector rebounds, government funding initiatives, and Al-driven growth. Historical data indicates resilience in periods of underperformance, with strategies poised for future gains. The presentation also details portfolio buys and sells, highlighting adjustments based on valuation, fundamentals, and market conditions. Pinnacle Associates emphasizes its independent, research-driven approach with a long-standing commitment to client service and sustainable investment performance.
