# Summary

# Manager Update Workshop

## a. Bell Partners

Meghan Burke, Zachary Daughtry, and Barbat Rodgers presented on Bell Partners, a Non-Core Real Estate manager overseeing a \$20 million commitment from the Jacksonville Police and Fire Pension Fund to Bell Partners Value-Add Fund VIII. Bell Partners has nearly 50 years of experience in market-rate apartments, operating 85,000 units nationwide with a vertically integrated platform. They pride themselves on leveraging data analytics and maintaining strong executive alignment, with consistent top-quartile performance. Since 2002, the company has generated \$11.1 billion in residential transactions, yielding a net 17.7% IRR, and continues to show growth despite market cycles.

The multifamily market remains favorable, with strong renter demand supported by demographic trends and the high cost of single-family homes. Although construction is slowing due to high costs and constrained financing, Bell's key regions benefit from job growth, keeping performance stable. Fund VIII has outperformed expectations, with occupancy at 94.3%, ahead of the budgeted 92.1%, and net operating income 17.4% above proforma. Ongoing capital projects are improving properties like Bell Lansbrook Village, Bell Murrieta Springs, and Bell Old Town, driving continued success across Bell Partners' portfolio.
