**Program Summary:** TEAM UP is an after school program that provides academic instruction, tutoring and support, as well as, enrichment activities, such as field trips, dance sports and arts to low income, at risk kids. These programs are housed in elementary and middle schools, and provide services directly after school for approximately 3 hours per day, five days per week.

**Successes**

Academics:

- Students are working to meet benchmark testing goals in reading and math
- Students have set a goal to increase by 10 points or more between the fall and winter benchmarks
- TEAM UP teachers are implementing the “Super Six” reading strategy and math teachers are following the district pacing guide for each grade level to increase understanding
- Students are expected to log their reading hours in their TEAM UP folder, and keep a sample of their work each week

Enrichment:

- Students are learning the fundamental of each enrichment activity and demonstrating what they have learned in the process
- Students are excited about the CIS Flag Football tournament and are excited about showing off their skills to peers from other TEAM UP site
- Students have gained a sense of belonging and sense of pride for individual enrichment activities offered

**Challenges:**

- Program continues to focus on additional partners to assist in providing additional avenues of support with recent cuts to program budget

- 98% of students attending Jacksonville Journey TEAM UP sites for 60 days or more will be free from physical harm and arrest. 5 class 3's
- 90% of students attending Jacksonville Journey TEAM UP sites for 60 days or more will be promoted to the next grade level.
- 90% of students attending Jacksonville Journey TEAM UP sites for 60 days or more will be absent from school less than 21 days.
- 90% of students attending Jacksonville Journey TEAM UP sites for 60 days or more will not receive a Class 3 or 4

referral/conduct violation.

- 60% of students attending on a regular basis will attend TEAM UP for 60 days or more
- Jacksonville Journey TEAM UP programs will maintain at least 97% of their projected average daily attendance.
