Program Summary: TEAM UP is an after school program that provides academic instruction, tutoring and support, as well as, enrichment activities, such as field trips, dance sports and arts to low income, at risk kids. These programs are housed in elementary and middle schools, and provide services directly after school for approximately 3 hours per day, five days per week.

Successes

- Academics: Students are expected to log their reading hours in their TEAM UP folder, and keep a sample of their work each week
- TEAM UP teachers are implementing the "Super Six" reading strategy and math teachers are following the district pacing guide for each grade level to increase understanding
- Students are working to meet benchmark testing goals in reading and math. Each student set a goal to increase by 10 points or more between the fall and winter benchmarks
- Students are excited about being able to track their own progress in academics

Enrichment:

- Students participated in the CIS/TEAM UP toy drive to assist families living at Hubbard House during Christmas
- Students participating in Flag Football are excited for the TEAM UP Football Championship in January 2013, so they can showcase their skills, abilities and play as a team and be proud of all the hard work they all put in
- TEAM UP of Fort Caroline enrichment such as, Dance, Step, Modeling, Music, and Cheerleading are preparing for 2013 show case and competitions
- TEAM UP students at Fort Caroline are excited about this time of the day, because there are advancing more in their enrichment. For example, students are learning the fundamental of each activity and showing what they have learned in the process.

Challenges:

• Challenges are minimal at this time but it should be noted that it is becoming increasingly difficult to maintain the level of service without increasing funding. Transportation and security cost drain the program financially but are desperately needed to maintain the structure of the program
