Successes: We have been able to add more students in order to maintain the ADA. FCAT preparation has started, and luckily we have the math and writing coach at GWC as a part of the Team Up staff. Since the 4 th graders at GWC have the lowest percentile for math scores, we have a math club every other Friday. This makes math more appealing to the students as well as help to better their understanding. There is also a science club every other Friday for 5 th graders, to						

help them better prepare for FCAT Science. In addition to the academic improvements, we have also added different enrichment activities: chess club, dance, arts and crafts, as well as ultimate frisbee. The students were able to choose which activity they wanted to participate in and they meet at least once a week with their group leader.

Challenges: The first part of the month was very difficult to get back into the swing of things and we had to spend a lot of additional time reviewing rituals and routines, as if it were the beginning of the year again. No other challenges at this time.
