Successes: Overall, student behaviors have become less of an issue. As students become used to the daily routine the days are running smoother. As a result of better behaviors we have been able to implement more activities such as art and using the computer lab on a daily basis. Another activity that was very successful was a "What Do I Like About Myself" Activity. So far only girls have done the activity, but I plan on the young men participating in the activity as well. On Wednesday, October 31st, students participated in Trick or Treating around the school, face painting and wearing costumes to celebrate Halloween. Parents donated an enormous amount of candy which made the event a success, and to add to the success we had a few parent volunteers. The feedback from other parents was the event served as a good alternative to taking their children Trick or Treating at night.

Challenges: The biggest issue for October was a student walking home after school instead of coming directly to Team Up. I have spoken to Principal Warren about there being sufficient supervision as the teachers escort the students to the cafeteria for Team Up at 3:00.
