AMENDMENT NUMBER ONE TO
AGREEMENT

BETWEEN

THE CITY OF JACKSONVILLE

AND

RIVER REGION HUMAN SERVICES, INC.

FOR

**Substance Abuse Education/Information, Treatment, Case Management and
After Care Program for Adult Inmates within the Duval County Correctional System**

THIS AMENDMENT NUMBER ONE TO AGREEMENT is made and entered into in duplicate this 15 day of NOV, 2013 (the "Effective Date"), by and between the CITY OF JACKSONVILLE (hereinafter referred to as the ACITY@), a municipal corporation existing under the Constitution and the laws of the State of Florida, and RIVER REGION HUMAN SERVICES, INC. (hereinafter referred to as the ACONSULTANT@), a Florida not-for-profit corporation with principal offices at 2055 Reyko Road, Suite 101, Jacksonville, Florida 32207, for Services related to Substance Abuse Education/Information, Treatment, Case Management and Aftercare Program for Adult Inmates within the Duval County Correctional System (hereinafter referred to as the AProject@).

RECITALS:

WHEREAS, previously, the Parties made and entered into City Contract #9442-26 (hereinafter referred to as the AAgreement@) for the Project; and

WHEREAS, said Agreement has not been amended previously; and

WHEREAS, said Agreement should be amended by acknowledging, ratifying and accepting the actions of the parties under and pursuant to said Agreement for the time frame from September 30, 2013 through the Effective Date; by exercising the first one-year renewal option, extending the period of service until September 30, 2014, with three one-year renewal options remaining; by increasing the CITY's maximum indebtedness by an amount not-to-exceed \$1,487,760.50 to a new total maximum indebtedness not-to-exceed \$2,975,521.00, with all other provisions, terms and conditions of said Agreement remaining unchanged; now therefore:

IN CONSIDERATION of the premises and of the mutual covenants and agreements hereinafter contained, the parties agree as follows:

- 1) The above stated recitals are accurate, true and correct and by this reference are incorporated herein and are made a part hereof.
- 2) The actions of the parties under the Agreement for the period from September 30, 2013 through the Effective Date are acknowledged, accepted and ratified.

3) Section 3.01 of said agreement is amended, in part, by exercising the first renewal option, extending the period of service until September 30, 2014 with three further one (1)- year renewal options remaining and, as amended, shall read as follows:

“3.01. The term of this Agreement shall commence effective October 1, 2012, and shall continue and remain in full force and effect as to all its terms, conditions and provisions as set forth herein until September 30, 2014, unless sooner terminated by either party, with or without cause, by giving not less than thirty (30) days’ prior written notice to the other party to this Agreement.”

4) ARTICLE 7, Section 7.01.02, of said Agreement, is amended, in part, by increasing the CITY=s maximum indebtedness by an amount not-to-exceed \$1,487,760.50 to a new total maximum indebtedness not-to-exceed \$7,310,066.12 and, as amended, shall read as follows:

A7.01.02. The maximum indebtedness of the CITY for all Services, expenses, reimbursable items or other costs for Services provided by the CONSULTANT pursuant to this Agreement shall not exceed the sum of TWO MILLION NINE HUNDRED SEVENTY-FIVE THOUSAND FIVE HUNDRED TWENTY-ONE AND NO/100 DOLLARS (\$2,975,521.00) for the term of this Agreement. @

SAVE AND EXCEPT as expressly amended by this instrument, the provisions, terms and conditions of said Agreement, as previously amended, shall remain unchanged and shall continue in full force and effect.





