CONTRACT
BETWEEN
THE CITY OF JACKSONVILLE
AND
SOUTHEASTERN STAINLESS FABRICATORS, INC.
FOR
ANTOINETTE LANE OUTFALL IMPROVEMENTS

THIS CONTRACT is executed as of this 19 day of Feb., 2014, by and between the CITY OF JACKSONVILLE, FLORIDA, a municipal corporation in Duval County, Florida, (hereinafter sometimes the "Owner" or the "City"), and SOUTHEASTERN STAINLESS FABRICATORS, INC., a Florida profit corporation with office at 634 Dyal Street, Jacksonville, Florida 32206 (hereinafter the "Contractor").

WITNESSETH, that for the consideration and under the provisions hereinafter stated and referred to moving from each to the other of said parties respectively, it is mutually understood and agreed as follows:

1. That Contractor is the lowest and best responsible bidder for furnishing all labor, materials, and equipment and performing all operations necessary to improve the drainage outfall running between 105th Street and Gaskins Road, including but not limited to tree removal, drainage structure and pipe removal, asphalt removal, fence removal and replacement, drain pipe and structure installation, ditch re-grading, placing and compacting fill material, hydroseed placement, sewer force main adjustment, water main adjustment, and all other related work, all in accordance with contract drawings, plans, and specifications hereinafter referred to and has been awarded this Contract for said work pursuant to award made December 9, 2013.

2. The Contractor will, at its own cost and expense, do the work required to be done and furnish the materials required to be furnished on said work in accordance with plans and specifications prepared by the Public Works Department of the City of Jacksonville, bid numbered JCF-0014-14, bid date October 29, 2013, designated *Antoinette Lane Outfall Improvements Contract Documents & Specifications*, and strictly in accordance with the advertisement calling for bids, plans, specifications, blueprints, addenda, requirements of the City of Jacksonville, proposal of the said Contractor, and award therefor (hereinafter collectively

the "Contract Documents") now on file in the Office of the Chief of the Procurement Division of the City of Jacksonville, all of which are hereby specifically made a part hereof by reference to the same extent as if fully set out herein for the total amount of ONE HUNDRED THIRTY-FOUR THOUSAND FIVE HUNDRED SIXTY AND 00/100 DOLLARS (\$134,560.00), at and for the prices and on the terms contained in the Contract Documents.

3. On the faithful performance of this Contract by the Contractor, the Owner will pay the Contractor in accordance with the terms and on the conditions stated in the Contract Documents.

4. This Contract and all amendments thereto may be executed in several counterparts, each of which shall be deemed to be an original, and all of such counterparts together shall constitute one and the same instrument.

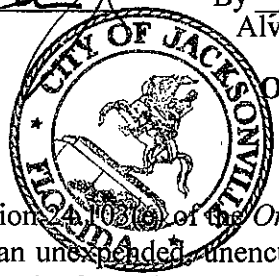
